Tentative Map and Neighborhood Development Permit to subdivide one lot with an existing single dwelling unit into two lots. The 0.296-acre project site is located at 2045 Galveston Street in the RS-1-7 (Residential Single) zone, a Sustainable Development Area, and the Clairemont Mesa Height Limitation Overlay zone within the Clairemont Mesa Community Plan. No physical development is proposed with this action.

This project was determined to be categorically exempt pursuant to Section 15315 (Minor Alterations and Land Divisions) and Section 15332 (In-Fill Development) of the California Environmental Quality Act.

ITEM 2: 5004 HASTINGS ROAD – PROJECT NO. PRJ-1108438

Plan Area: Mid-City/Kensington-Talmadge

Site Development Permit to permit an existing, unpermitted retaining wall and deck that encroach into the Multiple Habitat Planning Area (MHPA), add a custom pool and spa, add a drain outlet and riprap energy dissipater stormwater improvement, and process a MHPA Boundary Line Correction to remove areas from the City's planned conservation

area that were previously developed. The 0.55-acre site is in the RS-1-1 and RS-1-7 (Residential – Single Unit) zones as well as the OR-1-1 (Open Space – Residential) zone, the Airport Land Use Compatibility Overlay Zone (Montgomery Field); a Parking Standards Transit Priority Area; a Transit Priority Area; the Affordable Housing Parking Demand (High) overlay; the Airport Land Use Compatibility Plan Airport Influence Area (Montgomery Field - Review Area 2); the FAA Part 77 Noticing Area (Montgomery Field); the Multiple Habitat Planning Area; and the Very High Fire Hazard Severity Zone.

This project was determined to be categorically exempt pursuant to Section 15301 (Existing Facilities), 15303 (New Construction or Conversion of Small Structures) and 15304 (Minor Alterations to Land) of the California Environmental Quality Act.

The 0.035-acre vacant site is in the RM-1-1 zone (Residential – Multiple Unit) and a Transit Priority Area within the Southeastern San Diego Community Plan.

ITEM 4: 5360 CALUMET AVENUE – PROJECT NO. PRJ-1119583

Plan Area: La Jolla

Site Development Permit for the construction of a lower coastal bluff seawall within a developed parcel containing an existing single-dwelling unit. The 0.16-acre (7,300 square feet) project site is located at 5360 Calumet Avenue, in the Residential-Single Unit (RS-1-7) zone, Coastal Overlay Zone (COZ) – Appealable and California Coastal Commission permit jurisdiction, COZ- First Public Roadway, Sensitive COZ – Coastal Bluff, Coastal Height Limit Overlay Zone, and Parking Impact Overlay Zone – Beach Impact. This development is within the Coastal Overlay Zone, and a Coastal Development Permit is required through the California Coastal Commission.

This project was determined to be categorically exempt pursuant to Section 15303 (New Construction or Conversion of Small Structures) of the California Environmental Quality Act.

HOW TO PARTICIPATE IN HEARING OFFICER HEARINGS

TO SPEAK TO A PARTICULAR ITEM DURING PUBLIC COMMENT:

In Person for Agenda Items and Non-Agenda Public Comment: Please fill out a speaker slip located at the entrance to the meeting. Indicate the item you wish to speak on as well as other requested information. Then submit it to City staff.

Via Virtual Platform for Agenda Items and Non-Agenda Public Comment: When the Hearing Officer introduces the item (or indicates it is time for Non-Agenda Public Comment), raise your hand by either tapping the “Raise Your Hand” button on your computer, tablet, or Smartphone, or by dialing *9 on your phone. You will be taken in the order in which you raised your hand. You may only speak once on a particular item. When the Hearing Officer indicates it is your turn to speak, unmute your phone by tapping the unmute button on your computer, tablet or Smartphone, or dial *6 on your phone.

Please Note: Members of the public who wish to provide virtual testimony must enter the virtual queue by raising their hand before the queue closes. The queue will close when the last virtual speaker finishes speaking or five minutes after in-person testimony ends, whichever happens first. *Those participating virtually may NOT cede time to others participating in person or virtually.*

HOW TO PROVIDE WRITTEN COMMENTS:

For Agenda Items and Non-Agenda Public Comment: Submit using the [webform](#), indicating the comment type and item number (if relevant). Comments must be received by the business day prior for it to be distributed to the Hearing Officer. All webform comments are limited to 500 words but may include attachments. Comments received after the deadlines described above but before the item is called will be submitted into the written record for the relevant item. Written Materials: Instead of submitting materials as an attachment to the [webform](#), you may submit via U.S. Mail to the Hearing Officer at 7650 Mission Valley Road, MS DSD 1A, San Diego, CA 92108. Materials submitted via U.S. Mail must be received the business day prior for it to be distributed to the Hearing Officer.

Late-Arriving Materials:

Pursuant to the Brown Act, California Government Code Section 54957.5(b), late-arriving documents related to the Hearing Officer meeting agenda items which are distributed to the legislative body prior to and during the meeting are available for public review at the Development Services Department Building, 7650 Mission Valley Road, 1st Floor, San Diego, CA 92108. This relates to those documents received after the agenda is publicly noticed and during the 72 hours prior to the start of the meeting.
