Plan Area: Mid City Normal Heights, Central Urbanized Planned District

An application for a Site Development Permit and Easement Vacation to vacate an existing six-foot-wide public sewer easement totaling 430.56 square feet located within Lot 28, east of Benton Place and west of Interstate 15, and to construct a 1,680-square-foot, one-story single-family residence with a detached two-story building containing two 600-square-foot Accessory Dwelling Units (ADUs). The 0.73-acre vacant lot located at 0 Benton Place (Assessor's Parcel Number: 440-110-1600) is within the Normal Heights neighborhood of the Mid-City Communities Plan in the RS-1-1 (Residential-Single Unit), RS-1-7, and OR-1-1 (Open Space Residential) zones, the Airport Land Use Compatibility Overlay Zone (Montgomery Field), a Transit Priority Area, the Airport Influence Area for Montgomery Field (Review Area 2), the Federal Aviation Administration Part 77 Noticing Area (Montgomery Field 572'), the Multi-Habitat Planning Area (MHPA), Complete Communities Mobility Choices – Mobility Zone 2, and a Very High Fire Hazard Severity Zone.

This project was determined to be categorically exempt from the California Environmental Quality Act pursuant to Section 15303 (New Construction or Conversion of Small Structures).

ITEM 2: *2734 BORDEAUX AVENUE – PROJECT NO. PRJ-1087614**Staff:** Jose Bautista**City Council District:** 1**Plan Area:** La Jolla

An application for a Coastal Development Permit and Site Development Permit (amendment to CDP/SDP/La Jolla Shores Planned District Permit No. 41-0314) for a proposed detached 1,111-square-foot accessory dwelling unit with a basement, three roof gardens, three terraces, and associated site improvements. The 0.91-acre project site is located at 2734 Bordeaux Avenue in the La Jolla Shores Planned District–Single Family (LJSPD-SF) zone, the Coastal Overlay Zone (Non-Appealable), the Coastal Height Limit Overlay Zone, the Parking Impact Overlay Zone, a Parking Standards Transit Priority Area, a Transit Priority Area, and the Very High Fire Hazard Severity Zone within the La Jolla Community Plan and Local Coastal Program Land Use Plan area. The project site contains environmentally sensitive lands that include sensitive biological resources and steep hillsides. This development is within the Coastal Overlay Zone, and the application was filed on March 22, 2023.

ITEM 3: *THE CAMBRIDGE SCHOOL – PROJECT NO. PRJ-1109086**Staff:** Sara Osborn**City Council District:** 5**Plan Area:** Black Mountain Ranch

An application for a Conditional Use Permit for the construction of a pre-kindergarten through 12th-grade campus. The project would construct a 182,868-square-foot three-story classroom building, a 10,904-square-foot one-story multi-purpose building, and a track and sports field over a 70,766-square-foot semi-subterranean parking structure on a graded, vacant property located at the southwest corner of Camino Del Sur and Coyote Bush Drive. The 6.52-acre site (APN:678-690-7000, 678-690-7100, 678-690-7200) is in the Community Commercial (CC-4-5) zone, Complete Communities Mobility Zone 4, and the Urban Village Overlay Zone within the Black Mountain Ranch Community Plan.

HOW TO PARTICIPATE IN HEARING OFFICER HEARINGS

TO SPEAK TO A PARTICULAR ITEM DURING PUBLIC COMMENT:

In Person for Agenda Items and Non-Agenda Public Comment: Please fill out a speaker slip located at the entrance to the meeting. Indicate the item you wish to speak on as well as other requested information. Then submit it to City staff.

Via Virtual Platform for Agenda Items and Non-Agenda Public Comment: When the Hearing Officer introduces the item (or indicates it is time for Non-Agenda Public Comment), raise your hand by either tapping the “Raise Your Hand” button on your computer, tablet, or Smartphone, or by dialing *9 on your phone. You will be taken in the order in which you raised your hand. You may only speak once on a particular item. When the Hearing Officer indicates it is your turn to speak, unmute your phone by tapping the unmute button on your computer, tablet or Smartphone, or dial *6 on your phone.

Please Note: Members of the public who wish to provide virtual testimony must enter the virtual queue by raising their hand before the queue closes. The queue will close when the last virtual speaker finishes speaking or five minutes after in-person testimony ends, whichever happens first. *Those participating virtually may NOT cede time to others participating in person or virtually.*

Materials submitted via U.S. Mail must be received the business day prior for it to be distributed to the Hearing Officer.
