NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

PLANNING DEPARTMENT

PROJECT NAME/NUMBER: Park Use Permit - Sharon's Ride/Run/Walk

COMMUNITY PLAN AREA: Mission Bay Park **COUNCIL DISTRICT:** 2 **LOCATION:** De Anza Cove and internal pathways within Mission Bay Park

PROJECT DESCRIPTION: Approval of a Park Use Permit (PUP) to allow the 5K Run/Walk event use of Cityowned property within Mission Bay Park on April 18, 2021. This permit would allow the event, which would include the temporary use of the ride/run/walk route, festival, vendors, inflatables, portable restrooms, a stage, entertainment, canopies, tables, and chairs to occur at De Anza Cove Park and surrounding and pathways on April 18, 2021. Noise associated with the event activities and set-up/dismantling would occur from 4:30 AM until 12 PM on April 19, 2021. The ride/run/walk would occur on internal pathways of Mission Bay Park with participants obeying the rules of the road and no road closures or traffic rerouting would occur. The course would begin at De Anza Cove Park, travel south on the park pathway, then turn around and return to the finish at De Anza Cove Park. A stage would be used for entertainment/announcements and sound amplification would occur from 8:30 AM until 12 PM. On April 18, 2021, set-up would occur from 4:30 AM until 8:30 AM, the event would occur from 8:30 AM until 12 PM, and dismantling would occur from 12 PM until 2 PM. On April 19, 2021, dumpsters and portable restrooms would be picked up by 12 PM. Approximately 1,500 attendees would be anticipated during the course of the event.

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review and determined the project meets the categorical exemption criteria set forth in the CEQA State Guidelines: §Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; §Section 15304(e) (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; §Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to,

temporary use items in publicly owned facilities or other facilities designated for public use; §Section 15323 (Normal Operations of Facilities for Public Gatherings) which allows for the normal operations of existing facilities for public gatherings for which the facilities were designed, where there is a past history of the facility being used for the same or similar kind of purpose has been occurring for at least three years and that there is a reasonable expectation that the future occurrence of the project would not represent a change in the operation of the facility.

In addition, the exceptions set forth in the CEQA State Guidelines §15300.2 do not apply to this project wherein: a) the project would not impact an environmental resource of hazardous or critical concern where designated, precisely mapped, and officially adopted pursuant to law by federal, state, or local agencies; b) no cumulative impacts of successive projects of the same type in the same place were identified; c) there is no reasonable possibility that the project would have a significant effect on the environment due to unusual circumstances; d) the project would not result in damage to scenic resources, including but not limited to, trees, historic buildings, rock outcroppings, or similar resources, within a highway officially designated as a state scenic highway; e) the project is not located on a site which is included on any list compiled pursuant to Section 65962.5 of the Government Code; and f) the project would not cause a substantial adverse change in the significance of a historical resource.

You must separately mail the appeal fee by check payable to the City Treasurer to: City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101. The appeal filing fee must be postmarked within 5 business days of the date the appeal is filed.

2. Appeals filed via US Mail: Send the appeal by US Mail to City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101. Appeals filed by US Mail must have a United States Postal Service (USPS) postmark by the appeal deadline to be considered valid. The <u>appeal application can be obtained here</u>. You must separately mail the required appeal fee by check payable to the City Treasurer to: City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101. The appeal filing fee must be postmarked within 5 business days of the date the appeal is filed.
