NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

PLANNING DEPARTMENT

PROJECT NAME/NUMBER: Special Event Permit - Beaumont 4th of July Celebration & Parade

COMMUNITY PLAN AREA: La Jolla

COUNCIL DISTRICT: 1

LOCATION: Beaumont Avenue between Camino do La Costa and Via del Norte, and Mira Monte between the La Jolla Bike Path and Beaumont Avenue

PROJECT DESCRIPTION: Special Event Permit for a celebration that would include the temporary use of games, vendors, inflatables, a children's parade, a stage, fencing portable restrooms, tables, chairs, and entertainment on July 4, 2021. Noise associated with the event activities and set-up/dismantling would occur from 6 AM on July 3, 2021, until 5 PM on July 5, 2021. There would be one stage with entertainment and sound amplification would occur from 10 AM until 2 PM on July 4, 2021. Road closures would be associated with the event and would include Beaumont Avenue between Camino do La Costa and Via del Norte and Mira Monte between the La Jolla Bike Path and Beaumont Avenue from 6 AM until 4 PM on July 4, 2021. On July 3, 2021, set-up would occur from 6 AM until 5 PM. On July 4, 2021, set-up would occur from 6 AM until 10 AM, the event would occur from 10 AM until 2 PM, and dismantling would occur from 2 PM until 4 PM. On July 5, 2021, dismantling would occur from 6 AM until 5 PM.

ENVIRONMENTAL DETERMINATION: CEQA exemptions §Section 15301 (Existing Facilities); §Section 15304(e) (Minor Alterations to Land); §Section 15311 (Accessory Structures).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review and determined the project meets the categorical exemption criteria set forth in the CEQA State Guidelines: §Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; §Section 15304(e) (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; §Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities,

including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use.

In addition, the exceptions set forth in the CEQA State Guidelines §15300.2 do not apply to this project wherein: a) the project would not impact an environmental resource of hazardous or critical concern where designated, precisely mapped, and officially adopted pursuant to law by federal, state, or local agencies; b) no cumulative impacts of successive projects of the same type in the same place were identified; c) there is no reasonable possibility that the project would have a significant effect on the environment due to unusual circumstances; d) the project would not result in damage to scenic resources, including but not limited to, trees, historic buildings, rock outcroppings, or similar resources, within a highway officially designated as a state scenic highway; e) the project is not located on a site which is included on any list compiled pursuant to Section 65962.5 of the Government Code; and f) the project would not cause a substantial adverse change in the significance of a historical resource.

2. Appeals filed via US Mail: Send the appeal by US Mail to City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101. Appeals filed by US Mail must have a United States Postal Service (USPS) postmark by the appeal deadline to be considered valid. The [appeal application can be obtained here](#). The appeal filing fee must be postmarked within 5 business days of the date the appeal is filed.
