NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

PROJECT NAME/NUMBER: Special Event Permit - Balboa Park 8 Miler

COMMUNITY PLAN AREA: Balboa Park

COUNCIL DISTRICT: 3

LOCATION: Hall of Champions area in Balboa Park, surrounding roadways and pathways in Balboa

Park listed below

PROJECT DESCRIPTION: Special Event Permit for an 8 Miler race event that would occur in Balboa Park on August 7, 2021 and would include the run route, a stage, entertainment, and the temporary use of portable restrooms, canopies, tables, and chairs. Noise associated with the event activities and set-up/dismantling would occur from 2 AM until 11 AM on August 7, 2021. There would be a public announcement system used for announcements and entertainment and sound amplification would occur from 6:30 AM until 9:30 AM on August 7, 2021. The 3-mile course would begin on Pan American Way East, turn left onto El Prado, turn left on Balboa Drive, turn left onto 3th Drive, turn left onto Juniper Street, turn right onto 6th Avenue, turn right onto Balboa Drive, turn left onto El Prado, turn left onto Village Place, turn left onto Zoo Drive, turn left across the field in front of Roosevelt Middle School, turn left onto Upas Street, merge onto trails off Upas, turn left onto Bridal Trail, turn right onto Zig Zag, turn right onto Balboa Drive, turn left onto sidewalk, turn left onto Juniper Street, turn left onto Balboa Drive, turn right onto El Prado, and turn right onto Pan American Road East to the finish line. The following road closures would be associated with this event Pan America Road West, Pan American Road East, El Prado, and the Quince Street off-ramp (SR-163) from 5 AM until 9:30 AM; Balboa Drive between 6th Avenue and 3th Drive, and Juniper Street between Balboa Drive and 6th Avenue from 5:30 AM until 9:30 AM; NB lane of 6th Avenue between Juniper and Upas Streets from 6 AM until 7:45 AM; Village Place from 6 AM until 9:15 AM, and a single lane of Zoo Drive up to Park Boulevard from 6 AM until 9:30 AM. The Palisades Parking lot north would be closed to the public from 3 AM until 11 AM. On August 7, 2021, set-up would occur from 2 AM until 5:30 AM, the event would occur from 5:30 AM until 10 AM, and dismantling would occur from 10 AM until 11 AM.

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review and determined the project meets the categorical exemption criteria set forth in the CEQA State Guidelines: §Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; §Section 15304(e) (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; §Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use.

In addition, the exceptions set forth in the CEQA State Guidelines §15300.2 do not apply to this project wherein: a) the project would not impact an environmental resource of hazardous or critical concern where designated, precisely mapped, and officially adopted pursuant to law by federal, state, or local agencies; b) no cumulative impacts of successive projects of the same type in the same place were identified; c) there is no reasonable possibility that the project would have a significant effect on the environment due to unusual circumstances; d) the project would not result in damage to scenic resources, including but not limited to, trees, historic buildings, rock outcroppings, or similar resources, within a highway officially designated as a state scenic highway; e) the project is not located on a site which is included on any list compiled pursuant to Section 65962.5 of the Government Code; and f) the project would not cause a substantial adverse change in the significance of a historical resource.

The appeal filing fee must be postmarked within 5 business days of the date the appeal is filed.
- 2. Appeals filed via US Mail: Send the appeal by US Mail to City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101. Appeals filed by US Mail must have a United States Postal Service (USPS) postmark by the appeal deadline to be considered valid. The <u>appeal application can be obtained here</u>. You must

separately mail the required appeal fee by check payable to the City Treasurer to: City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101. The appeal filing fee must be postmarked within 5 business days of the date the appeal is filed.
