NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

PLANNING DEPARTMENT

PROJECT NAME/NUMBER: Special Event Permit – 14th Annual Bike the Bay

COMMUNITY PLAN AREA: Downtown and Barrio Logan

COUNCIL DISTRICT: 3 and 8

LOCATION: Embarcadero Marina Park South, Harbor Drive, Cesar Chavez Parkway, National Avenue

PROJECT DESCRIPTION: Special Event Permit for that portion of the Bike the Bay event that would occur within the City of San Diego's right-of-way jurisdiction on August 22, 2021. The event would include a fenced-in beer garden and entertainment at the Embarcadero Marina Park South (port jurisdiction) and bicycling on city roadways. For the start/finish area and the bicycling portion on city roadways, noise associated with the event activities and set-up/dismantling would occur from 9 AM on August 21, 2021, until 3 PM on August 22, 2021. The portion of the cycling event that would occur on city roadways would include Convention Way, Park Boulevard, Harbor Drive, Cesar Chavez Parkway, and National Avenue. No road closures would occur with this event. At Embarcadero Marina Park South, there would be one stage with entertainment and sound amplification would occur from 9 AM until 1:30 PM on August 22, 2021. On August 21, 2021, set-up would occur from 9 AM until 2 PM. On August 22, 2021, for that portion of the event that would be within the City's jurisdiction, set-up would occur from 4 AM until 7 AM, the event would occur from 7 AM until 2 PM, and dismantling would occur from 12 PM until 3 PM.

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review and determined the project meets the categorical exemption criteria set forth in the CEQA State Guidelines: §Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; §Section 15304(e) (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; §Section 15311 (Accessory Structures) which allows for construction, or

placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use.

In addition, the exceptions set forth in the CEQA State Guidelines §15300.2 do not apply to this project wherein: a) the project would not impact an environmental resource of hazardous or critical concern where designated, precisely mapped, and officially adopted pursuant to law by federal, state, or local agencies; b) no cumulative impacts of successive projects of the same type in the same place were identified; c) there is no reasonable possibility that the project would have a significant effect on the environment due to unusual circumstances; d) the project would not result in damage to scenic resources, including but not limited to, trees, historic buildings, rock outcroppings, or similar resources, within a highway officially designated as a state scenic highway; e) the project is not located on a site which is included on any list compiled pursuant to Section 65962.5 of the Government Code; and f) the project would not cause a substantial adverse change in the significance of a historical resource.

During the Statewide "Safer-at-Home" directive to reduce the spread of COVID-19, beginning March 19, 2021, appeals to the City Clerk must be filed by email or US Mail as follows:

The appeal filing fee must be postmarked within 5 business days of the date the appeal is filed.
- 2. Appeals filed via US Mail: Send the appeal by US Mail to City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101. Appeals filed by US Mail must have a United States Postal Service (USPS) postmark by the appeal deadline to be considered valid. The <u>appeal application can be obtained here</u>. The appeal filing fee must be postmarked within 5 business days of the date the appeal is filed.
