NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

PROJECT NAME/NUMBER: Special Event Permit - La Vuelta Summer Festival

COMMUNITY PLAN AREA: Barrio Logan **COUNCIL DISTRICT:** 8 **LOCATION:** Logan Avenue, Evans Street, and Sampson Street in Barrio Logan

PROJECT DESCRIPTION: Special Event Permit for a free community event that would include the temporary use of car clubs, vendors, food trucks, two fenced-in beer gardens, a stage, entertainment, canopies, tables, and chairs that would occur on Logan Avenue, Evans Street, and Sampson Street in Barrio Logan on August 21, 2021 from 10 AM until 5 PM. Noise associated with the event activities and set-up/dismantling would occur from 5 AM until 7 PM on August 21, 2021. Road closures associated with the event would include Logan Avenue between 26th Street and one-half block north of the Evans Street intersection, Evans Street east of National Avenue to the dead end, and Sampson Street between National Avenue and Kearney Avenue from 5 AM until 7 PM. There would be a stage with entertainment, and sound amplification would occur from 9 AM until 5 PM. On August 21, 2021, set-up would occur from 5 AM until 10 AM, the event would occur from 10 AM until 5 PM, and clean-up/dismantling would occur from 5 PM until 7 PM.

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review and determined the project meets the categorical exemption criteria set forth in the CEQA State Guidelines: §Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; §Section 15304(e) (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; §Section 15311 (Accessory Structures) which allows for

construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use.

In addition, the exceptions set forth in the CEQA State Guidelines §15300.2 do not apply to this project wherein: a) the project would not impact an environmental resource of hazardous or critical concern where designated, precisely mapped, and officially adopted pursuant to law by federal, state, or local agencies; b) no cumulative impacts of successive projects of the same type in the same place were identified; c) there is no reasonable possibility that the project would have a significant effect on the environment due to unusual circumstances; d) the project would not result in damage to scenic resources, including but not limited to, trees, historic buildings, rock outcroppings, or similar resources, within a highway officially designated as a state scenic highway; e) the project is not located on a site which is included on any list compiled pursuant to Section 65962.5 of the Government Code; and f) the project would not cause a substantial adverse change in the significance of a historical resource.

Appeals filed by US Mail must have a United States Postal Service (USPS) postmark by the appeal deadline to be considered valid. The <u>appeal application can be obtained here</u>. The appeal filing fee must be postmarked within 5 business days of the date the appeal is filed.
