# **NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION**

**PROJECT NAME/NUMBER:** Special Event Permit – Weekend Activations (The New Children's Museum)

**COMMUNITY PLAN AREA:** Downtown

**COUNCIL DISTRICT:** 3

**LOCATION:** 200 block of West Island Avenue, Children's Museum Park at 255 West Island Avenue

**PROJECT DESCRIPTION:** Special Event Permit for a series of outdoor museum activities at the Children's Museum Park at 255 West Island Avenue and the 200 block of West Island Avenue that would allow for the temporary use of food trucks, food vendors, fencing, canopies, tables, and chairs be used during the event and would occur on weekends and school holidays for the following dates in 2021: October 2, 3, 9, 10, 16, 17, 23, 24, 30, and 31; November 6, 7, 11, 13, 14, 20, 21, 22, 23, 24, and 25; and December 4, 5, 11, 12, 18, 19, 20, 21, 22, 23, 24, 27, 28, 29, 30, and 31. Noise associated with the event activities and set-up/dismantling would occur from 8:30 AM until 5 PM on the dates listed above. A road closure would be associated with the events and would occur daily from 8:30 AM until 5 PM on the 200 block of West Island Avenue on the dates listed above. There would be background music and announcements throughout the events, and sound amplification would occur from 9 AM until 4 PM on the event dates listed above. On October 2, 3, 9, 10, 16, 17, 23, 24, 30, and 31; November 6, 7, 11, 13, 14, 20, 21, 22, 23, 24, and 25; and December 4, 5, 11, 12, 18, 19, 20, 21, 22, 23, 24, 27, 28, 29, 30, and 31, set-up would occur from 8:30 AM until 9 AM, the event would occur from 9 AM until 4 PM, and dismantling would occur from 4 PM until 5 PM.

**ENTITY MAKING ENVIRONMENTAL DETERMINATION:** City of San Diego Mayor-Appointed Designee

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review and determined the project meets the categorical exemption criteria set forth in the CEQA State Guidelines: §Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; §Section 15304(e) (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; §Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use.

In addition, the exceptions set forth in the CEQA State Guidelines §15300.2 do not apply to this project wherein: a) the project would not impact an environmental resource of hazardous or critical concern where designated, precisely mapped, and officially adopted pursuant to law by federal, state, or local agencies; b) no cumulative impacts of successive projects of the same type in the same place were identified; c) there is no reasonable possibility that the project would have a significant effect on the environment due to unusual circumstances; d) the project would not result in damage to scenic resources, including but not limited to, trees, historic buildings, rock outcroppings, or similar resources, within a highway officially designated as a state scenic highway; e) the project is not located on a site which is included on any list compiled pursuant to Section 65962.5 of the Government Code; and f) the project would not cause a substantial adverse change in the significance of a historical resource.

Appeals filed by US Mail must have a United States Postal Service (USPS) postmark by the appeal deadline to be considered valid. The [appeal application can be obtained here](#). You must separately mail the required appeal fee by check payable to the City Treasurer to: City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101. The appeal filing fee must be postmarked within 5 business days of the date the appeal is filed.
