## NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

## PLANNING DEPARTMENT

**PROJECT NAME:** Special Event Permit – Alzheimer's Walk

**COMMUNITY PLAN AREA:** Balboa Park

**COUNCIL DISTRICT: 3** 

**LOCATION:** Eastern portion of Balboa Park, El Prado, and surrounding roadways

**PROJECT DESCRIPTION:** Special Event Permit for a fundraising walk event and expo that would include the temporary use of the walk, food, vendors, a stage, entertainment, canopies, tables, and chairs that would occur in Balboa Park and the surrounding roadways on October 16, 2021. Noise associated with the event activities and set-up/dismantling would occur from 8 AM on October 15, 2021, until 2 PM on October 16, 2021. There would be one stage for announcements/entertainment and sound amplification would occur from 7 AM until 11 AM. The walk route would start/end at Pan American Plaza, head north on Pan American Road, turn left onto El Prado, turn left onto Balboa Drive, complete loop, turn right onto El Prado, turn right onto Pan American Road, and finish at Pan American Plaza. The following road closures associated with the event would occur from 6 AM until 10 AM on October 19, 2021, and would include Laurel Street east of 6th Avenue, El Prado, and Pan American Road East. On October 15, 2021, set-up would occur from 8 AM until 3 PM. On October 16, 2021, set-up would occur from 4 AM until 5 AM, the event would occur from 5 AM until 10 AM, and dismantling would occur from 10 AM until 2 PM.

**ENVIRONMENTAL DETERMINATION:** CEQA exemptions §Section 15301 (Existing Facilities); §Section 15304(e) (Minor Alterations to Land); §Section 15311 (Accessory Structures); §Section 15323 (Normal Operations of Facilities for Public Gatherings).

**ENTITY MAKING ENVIRONMENTAL DETERMINATION:** City of San Diego Mayor-Appointed Designee

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review and determined the project meets the categorical exemption criteria set forth in the CEQA State Guidelines: §Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; §Section 15304(e) (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; §Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities,

including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; §Section 15323 (Normal Operations of Facilities for Public Gatherings) which allows for the normal operations of existing facilities for public gatherings for which the facilities were designed, where there is a past history of the facility being used for the same or similar kind of purpose has been occurring for at least three years and that there is a reasonable expectation that the future occurrence of the project would not represent a change in the operation of the facility.

In addition, the exceptions set forth in the CEQA State Guidelines §15300.2 do not apply to this project wherein: a) the project would not impact an environmental resource of hazardous or critical concern where designated, precisely mapped, and officially adopted pursuant to law by federal, state, or local agencies; b) no cumulative impacts of successive projects of the same type in the same place were identified; c) there is no reasonable possibility that the project would have a significant effect on the environment due to unusual circumstances; d) the project would not result in damage to scenic resources, including but not limited to, trees, historic buildings, rock outcroppings, or similar resources, within a highway officially designated as a state scenic highway; e) the project is not located on a site which is included on any list compiled pursuant to Section 65962.5 of the Government Code; and f) the project would not cause a substantial adverse change in the significance of a historical resource.
