# NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

**PROJECT NAME/NUMBER:** Special Event Permit - Bike the Coast

**COMMUNITY PLAN AREAS:** Torrey Pines, Carmel Valley, NCFUA, Via De La Valle

**COUNCIL DISTRICT:** 1

**LOCATION:** Carmel Valley Road at Pacific Coast Highway, Sorrento Valley Road, Carmel Mountain Road, El Camino Real, and Via De La Valle

**PROJECT DESCRIPTION:** Special Event Permit for that portion of the annual Bike the Coast event that would occur within the City of San Diego's jurisdiction on November 6, 2021. The noncompetitive bicycle ride begins and ends in another jurisdiction and makes use of some community roadways within the northwestern portion of San Diego. Noise associated with this event would occur from 6:30 AM until 12 PM on November 6, 2021. Riders would enter the City of San Diego on Carmel Valley Road at Pacific Coast Highway, head east, turn right onto Sorrento Valley Road, u-turn near Performance Bicycle, turn right onto Carmel Mountain Road, turn left onto El Camino Real, turn left onto Via De La Valle, and leave the City to complete the ride in other jurisdictions. No road closures would occur with this event, and all riders will abide by rules of the road. Estimated attendees is 1500.

**ENTITY MAKING ENVIRONMENTAL DETERMINATION:** City of San Diego Mayor-Appointed Designee

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review and determined the project meets the categorical exemption criteria set forth in the CEQA State Guidelines: §Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; §Section 15304(e) (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; §Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; §Section 15323 (Normal Operations of Facilities for Public Gatherings) which allows for the normal operations of existing facilities for public gatherings for which the facilities

were designed, where there is a past history of the facility being used for the same or similar kind of purpose has been occurring for at least three years and that there is a reasonable expectation that the future occurrence of the project would not represent a change in the operation of the facility.

In addition, the exceptions set forth in the CEQA State Guidelines §15300.2 do not apply to this project wherein: a) the project would not impact an environmental resource of hazardous or critical concern where designated, precisely mapped, and officially adopted pursuant to law by federal, state, or local agencies; b) no cumulative impacts of successive projects of the same type in the same place were identified; c) there is no reasonable possibility that the project would have a significant effect on the environment due to unusual circumstances; d) the project would not result in damage to scenic resources, including but not limited to, trees, historic buildings, rock outcroppings, or similar resources, within a highway officially designated as a state scenic highway; e) the project is not located on a site which is included on any list compiled pursuant to Section 65962.5 of the Government Code; and f) the project would not cause a substantial adverse change in the significance of a historical resource.

Appeals filed by US Mail must have a United States Postal Service (USPS) postmark by the appeal deadline to be considered valid. The [appeal application can be obtained here](#). The appeal filing fee must be postmarked within 5 business days of the date the appeal is filed.
