NOTICE OF RIGHT TO APPEAL

ENVIRONMENTAL DETERMINATION

PROJECT NAME/NUMBER: Special Event Permit – November Project Relay Challenge

COMMUNITY PLAN AREA: Mission Beach

COUNCIL DISTRICT: 2

LOCATION: Mission Beach and along the Mission Beach Boardwalk

PROJECT DESCRIPTION: Special Event Permit for an athletic and relay event at Mission Beach Park and along Mission Beach Boardwalk on November 12, 2021 and November 13, 2021. The event would include vendors, a fenced-in beer garden, entertainment, a stage, amplification, and the temporary use of canopies, tables, chairs, generators, trash containers, dumpsters, and portable toilets. Noise associated with the event activities and set-up/dismantling would occur from 6 AM to 6 PM on November 12, 2021 and from 6 AM to 10 PM on November 13, 2021. The relay will start in Mission Beach Park, continue north on the boardwalk, u turn at Ormond Ct where runners travel south on the boardwalk, u turn at south Mission beach Park to the finish line. Approximately fifteen parking spaces would be closed at Mission Beach Park for the event on November 13, 2021 from 4 AM to 2 PM.

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review and determined the project meets the categorical exemption criteria set forth in the CEQA State Guidelines: §Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; §Section 15304(e) (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; §Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use.

In addition, the exceptions set forth in the CEQA State Guidelines §15300.2 do not apply to this project wherein: a) the project would not impact an environmental resource of hazardous or critical concern where

designated, precisely mapped, and officially adopted pursuant to law by federal, state, or local agencies; b) no cumulative impacts of successive projects of the same type in the same place were identified; c) there is no reasonable possibility that the project would have a significant effect on the environment due to unusual circumstances; d) the project would not result in damage to scenic resources, including but not limited to, trees, historic buildings, rock outcroppings, or similar resources, within a highway officially designated as a state scenic highway; e) the project is not located on a site which is included on any list compiled pursuant to Section 65962.5 of the Government Code; and f) the project would not cause a substantial adverse change in the significance of a historical resource.

2. Appeals filed via US Mail: Send the appeal by US Mail to City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101. Appeals filed by US Mail must have a United States Postal Service (USPS) postmark by the appeal deadline to be considered valid. The [appeal application can be obtained here](#). The appeal filing fee must be postmarked within 5 business days of the date the appeal is filed.
