# **NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION**

**PROJECT NAME/NUMBER:** Special Event Permit – Challenge Walk MS 2021

**COMMUNITY PLAN AREA:** City roadways, Ellen Browning Scripps Park, Ventura

**COUNCIL DISTRICT:** 1 & 2

**LOCATION:** Torrey Pines, University City, La Jolla, Pacific Beach & Mission Beach

**PROJECT DESCRIPTION:** Special Event Permit for that portion of a three-day walk event that would occur within the City of San Diego's jurisdiction and would include the routes, rest areas, and finish area that would include portable restrooms, canopies, tables, and chairs on November 13, 2021. Noise associated with the event activities and set-up/dismantling within the City's jurisdiction would occur from 8 AM until 6:30 PM on November 13, 2021. Approximate attendance is 200. The event/walk at the top of Torrey Pines to Bonita Cove would occur from 8:30AM to 6:00PM. Expected number of attendees is 200.

The route within the City of San Diego would be from S Camino Del Mar onto N Torrey Pines Road, right on Torrey Pines Park Rd, right on North Torrey Pines Rd, right on Torrey Pines Scenic Dr, right on North Torrey Pines Rd, right on La Jolla Shores Dr, right on Camino Del Oro, left on Avenida De la Playa, right on Calle De La Plata, right on Paseo Dorado, onto Spindrift Dr and Princess St, right on Torrey Pines Rd, right on Prospect Pl, right on Cave St, onto Coast Blvd, right on Olivetas Ave, right on Dunemere Dr, left on Monte Vista Ave, right on Fern Glen, onto Neptune Pl, left on Palomar Ave, right on Camino De La Costa, right on La Jolla Blvd, right on Midway St, left on Calumet Ave, onto Sea Ridge Dr, right on Chelsea St, right on La Jolla Blvd, right on Law St, left on Ocean Blvd Boardwalk, left on Ventura Place, and finish at Bonita Cove.

**ENVIRONMENTAL DETERMINATION:** CEQA exemptions §Section 15301 (Existing Facilities); §Section 15304(e) (Minor Alterations to Land); §Section 15311 (Accessory Structures); §Section 15323 (Normal Operations of Facilities for Public Gatherings).

**ENTITY MAKING ENVIRONMENTAL DETERMINATION:** City of San Diego Mayor-Appointed Designee

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review and determined the project meets the categorical exemption criteria set forth in the CEQA State Guidelines: §Section 15301 (Existing Facilities) which allows for the

operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; §Section 15304(e) (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; §Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; §Section 15323 (Normal Operations of Facilities for Public Gatherings) which allows for the normal operations of existing facilities for public gatherings for which the facilities were designed, where there is a past history of the facility being used for the same or similar kind of purpose has been occurring for at least three years and that there is a reasonable expectation that the future occurrence of the project would not represent a change in the operation of the facility.

In addition, the exceptions set forth in the CEQA State Guidelines §15300.2 do not apply to this project wherein: a) the project would not impact an environmental resource of hazardous or critical concern where designated, precisely mapped, and officially adopted pursuant to law by federal, state, or local agencies; b) no cumulative impacts of successive projects of the same type in the same place were identified; c) there is no reasonable possibility that the project would have a significant effect on the environment due to unusual circumstances; d) the project would not result in damage to scenic resources, including but not limited to, trees, historic buildings, rock outcroppings, or similar resources, within a highway officially designated as a state scenic highway; e) the project is not located on a site which is included on any list compiled pursuant to Section 65962.5 of the Government Code; and f) the project would not cause a substantial adverse change in the significance of a historical resource.

The appeal filing fee must be postmarked within 5 business days of the date the appeal is filed.
2. Appeals filed via US Mail: Send the appeal by US Mail to City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101. Appeals filed by US Mail must have a United States Postal Service (USPS) postmark by the appeal deadline to be considered valid. The [appeal application can be obtained here](#). You must
