NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

PLANNING DEPARTMENT

PROJECT NAME: Special Event Permit – CoStar

COMMUNITY PLAN AREA: Downtown COUNCIL DISTRICT: 3

LOCATION: 5th Ave between L and J Street, K street between 4th and 6th, J street between 4th and 6th

PROJECT DESCRIPTION: Special Event Permit for a private corporate block party on November 13, 2021. On November 13, 2021 the set-up time would be from 6 am to 6 pm, the event would be from 6 pm to 10:30 pm, and dismantling would be from 10 pm to 11:55pm. On November 14, 2021 the dismantling will continue from 12am to 6 am. Noise associated with the event activities and set-up/dismantling would occur from 6 am on November 13, 2021 through 6 am November 14, 2021. There would be stages, food, entertainment, fences, tables, chairs, outside bar, alcohol, portable restrooms, generators, on site lighting, drones taking videos and photos of the party, during the event on November 13, 2021. Road Closures would include 5th Ave between L and J Street, K street between 4th and 6th, J street between 4th and 6th from 6 am – 10 pm for the event on November 13, 2021 and continue through 6 am November 14, 2021 for dismantling. There would be no parking on 4th Avenue between J and K Streets for EMT staff and cleaning. Shuttles will be dropping attendees at entrances located at 4th and K and 4th and J or 6th and K or 6 and J Streets. Approximately 5,000 attendees are anticipated to attend this event.

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review and determined the project meets the categorical exemption criteria set forth in the CEQA State Guidelines: §Section 15301 (Existing Facilities) which

allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; §Section 15304(e) (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; §Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; §Section 15323 (Normal Operations of Facilities for Public Gatherings) which allows for the normal operations of existing facilities for public gatherings for which the facilities were designed, where there is a past history of the facility being used for the same or similar kind of purpose has been occurring for at least three years and that there is a reasonable expectation that the future occurrence of the project would not represent a change in the operation of the facility.

In addition, the exceptions set forth in the CEQA State Guidelines §15300.2 do not apply to this project wherein: a) the project would not impact an environmental resource of hazardous or critical concern where designated, precisely mapped, and officially adopted pursuant to law by federal, state, or local agencies; b) no cumulative impacts of successive projects of the same type in the same place were identified; c) there is no reasonable possibility that the project would have a significant effect on the environment due to unusual circumstances; d) the project would not result in damage to scenic resources, including but not limited to, trees, historic buildings, rock outcroppings, or similar resources, within a highway officially designated as a state scenic highway; e) the project is not located on a site which is included on any list compiled pursuant to Section 65962.5 of the Government Code; and f) the project would not cause a substantial adverse change in the significance of a historical resource.

2. Appeals filed via US Mail: Send the appeal by US Mail to City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101. Appeals filed by US Mail must have a United States Postal Service (USPS) postmark by the appeal deadline to be considered valid. The <u>appeal application can be obtained</u> <u>here</u>. You must separately mail the required appeal fee by check payable to the City Treasurer to: City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101. The appeal filing fee must be postmarked within 5 business days of the date the appeal is filed.
