NOTICE OF RIGHT TO APPEAL

ENVIRONMENTAL DETERMINATION

PROJECT NAME/NUMBER: Special Event Permit – 2021 San Diego Jingle Bell Run

COMMUNITY PLAN AREA: Peninsula

COUNCIL DISTRICT: 2

LOCATION: NTC Liberty Station

PROJECT DESCRIPTION: Special Event Permit for a SK run/walk event that would include a fenced-in beer garden, a kids' zone, a stage, amplified sound, food, entertainment, portable restrooms, canopies, tables, and chairs that would occur in Preble Field NTC Liberty Station on December 11, 2021. Noise associated with the event activities and set-up/dismantling would occur from 2 PM to 7 PM on December 10, 2021, and from 5 AM to 12 PM on December 11, 2021. On December 10, 2021, set-up would occur from 2 PM until 7 PM. On December 11, 2021, the event would occur from 5 AM until 12 PM, and dismantling would occur from 11 AM until 12 PM. The Beer Garden would occur from 9 AM to 11 AM on December 11, 2021 and music and entertainment would occur from 7 AM to 11 AM.

The run/walk route would begin on Cushing Road heading east on Cushing, turn right onto Chauncey Road, follow pathways through the park, go around the USS Recruit, cross over Halsey Bridge, u-turn, and follow pathways back to the start/finish area. A road closure associated with the event would occur on Cushing Road between Roosevelt and Chauncey Street from 6 AM until 10 AM on December 11, 2021.

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review and determined the project meets the categorical exemption criteria set forth in the CEQA State Guidelines: §Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; §Section 15304(e) (Minor Alterations to

Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; §Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use.

In addition, the exceptions set forth in the CEQA State Guidelines §15300.2 do not apply to this project wherein: a) the project would not impact an environmental resource of hazardous or critical concern where designated, precisely mapped, and officially adopted pursuant to law by federal, state, or local agencies; b) no cumulative impacts of successive projects of the same type in the same place were identified; c) there is no reasonable possibility that the project would have a significant effect on the environment due to unusual circumstances; d) the project would not result in damage to scenic resources, including but not limited to, trees, historic buildings, rock outcroppings, or similar resources, within a highway officially designated as a state scenic highway; e) the project is not located on a site which is included on any list compiled pursuant to Section 65962.5 of the Government Code; and f) the project would not cause a substantial adverse change in the significance of a historical resource.

2. Appeals filed via US Mail: Send the appeal by US Mail to City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101. Appeals filed by US Mail must have a United States Postal Service (USPS) postmark by the appeal deadline to be considered valid. The [appeal application can be obtained here](#). The appeal filing fee must be postmarked within 5 business days of the date the appeal is filed.
