## NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

PROJECT NAME/NUMBER: Special Event Permit - Live Nativity Drive-Thru

**COMMUNITY PLAN AREA:** Rancho Bernardo

**COUNCIL DISTRICT: 5** 

LOCATION: Rancho Bernardo Community Presbyterian Church, 17010 Pomerado Road

**PROJECT DESCRIPTION:** Special Event Permit for a live Nativity Drive-Thru event while listening to the Christmas story on the radio driving by eight stations of nativity scenes with live stationary actors and animals. The event would occur on December 19, 2021. The event/ nativity scenes will be displayed within the parking lot of the Rancho Bernardo Community Presbyterian Church. Noise associated with the event activities and set-up/dismantling would occur from 10 AM until 11 PM on December 19, 2021. Set up would occur from 10 AM to 2:05 PM, the event would occur from 5 PM to 9 PM and dismantling would occur from 9 PM to 11PM. Lane closures for through traffic would occur and would be designated for the event traffic only. Those lanes are as follows: Northbound lane #1 from Rancho Bernardo Road to Pomerado Court and the southbound lane #2 from Pomerado Court to the Rancho Bernardo Community Presbyterian Church parking lot. These lanes would be designated for the event traffic only from 5 PM to 9 PM on December 19, 2021. The total expected number attendees would be approximately 2000.

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review and determined the project meets the categorical exemption criteria set forth in the CEQA State Guidelines: §Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; §Section 15304(e) (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; §Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to,

temporary use items in publicly owned facilities or other facilities designated for public use.

In addition, the exceptions set forth in the CEQA State Guidelines §15300.2 do not apply to this project wherein: a) the project would not impact an environmental resource of hazardous or critical concern where designated, precisely mapped, and officially adopted pursuant to law by federal, state, or local agencies; b) no cumulative impacts of successive projects of the same type in the same place were identified; c) there is no reasonable possibility that the project would have a significant effect on the environment due to unusual circumstances; d) the project would not result in damage to scenic resources, including but not limited to, trees, historic buildings, rock outcroppings, or similar resources, within a highway officially designated as a state scenic highway; e) the project is not located on a site which is included on any list compiled pursuant to Section 65962.5 of the Government Code; and f) the project would not cause a substantial adverse change in the significance of a historical resource.

Appeals filed by US Mail must have a United States Postal Service (USPS) postmark by the appeal deadline to be considered valid. The appeal application can be obtained here. You must separately mail the required appeal fee by check payable to the City Treasurer to: City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101. The appeal filing fee must be postmarked within 5 business days of the date the appeal is filed.
