NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

PLANNING DEPARTMENT

PROJECT NAME/NUMBER: Special Event Permit – Holiday Bowl Parade

COMMUNITY PLAN AREA: Downtown

COUNCIL DISTRICT: 3

LOCATION: Harbor Drive

PROJECT DESCRIPTION: Special Event Permit for a holiday parade event that would include marching bands, floats, vehicles, amplified sound, balloons, tents, fencing and/or barriers, tables and chairs. The event would occur along Harbor Drive on December 28, 2021. Noise associated with the event activities and set-up /dismantling would occur from December 27, 2021 at 6 AM through December 28, 2021 at 5 PM. Set-up would occur on December 27, 2021 from 6 AM until 5:30 PM, and on December 28, 2021 from 5 AM to 10 AM, the parade would occur on December 28, 2021 from 10 AM until 11:30 AM and dismantling would occur from 11:30 AM until 5 PM. The parade route would stage along Pacific Highway and Grape Street, begin on North Harbor Drive heading south, finish at Pacific Highway, and disband on Pacific Highway. Road closures associated with the parade would occur and include Harbor Drive between Grape and Broadway from 8:30 AM to 1 PM, Pacific Highway between Harbor Drive and Broadway and Harbor Drive between Broadway and Pacific Highway would both close at 8 AM and open to traffic at 1 PM. Anticipated number of attendees would be approximately 60,000.

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review and determined the project meets the categorical exemption criteria set forth in the CEQA State Guidelines: §Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; §Section 15304(e) (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; §Section 15311 (Accessory Structures) which allows for construction, or placement of minor

structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use.

In addition, the exceptions set forth in the CEQA State Guidelines §15300.2 do not apply to this project wherein: a) the project would not impact an environmental resource of hazardous or critical concern where designated, precisely mapped, and officially adopted pursuant to law by federal, state, or local agencies; b) no cumulative impacts of successive projects of the same type in the same place were identified; c) there is no reasonable possibility that the project would have a significant effect on the environment due to unusual circumstances; d) the project would not result in damage to scenic resources, including but not limited to, trees, historic buildings, rock outcroppings, or similar resources, within a highway officially designated as a state scenic highway; e) the project is not located on a site which is included on any list compiled pursuant to Section 65962.5 of the Government Code; and f) the project would not cause a substantial adverse change in the significance of a historical resource.

During the Statewide "Safer-at-Home" directive to reduce the spread of COVID-19, beginning March 19, 2021, appeals to the City Clerk must be filed by email or US Mail as follows:

You must separately mail the appeal fee by check payable to the City Treasurer to: City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101. The appeal filing fee must be postmarked within 5 business days of the date the appeal is filed.
- 2. Appeals filed via US Mail: Send the appeal by US Mail to City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101. Appeals filed by US Mail must have a United States Postal Service (USPS) postmark by the appeal deadline to be considered valid. The <u>appeal application can be obtained here</u>. You must separately mail the required appeal fee by check payable to the City Treasurer to: City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101. The appeal filing fee must be postmarked within 5 business days of the date the appeal is filed.
