NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

PROJECT NAME/NUMBER: Special Event Permit – Snapdragon Bowl Bash

COMMUNITY PLAN AREA: Downtown

COUNCIL DISTRICT: 3

LOCATION: 5th Ave between F Street and J Street

PROJECT DESCRIPTION: Special Event Permit for an inaugural Snapdragon Bowl Bash in the Gaslamp Quarters on December 27, 2021. The event would include merchandise & sponsor tents, bands, various activities, marching bands, photo station, face paintings and performances. The event will also include stages, bleachers, fencing and/or barriers, tables, seating, and amplified sound.

Noise associated with the event activities and set-up/dismantling would occur on December 27, 2021 from 8 AM until 1 AM on December 28, 2021. Set-up would occur from 8 AM until 5 PM, the event on occur from 5 PM until 8 PM, and dismantling would occur from 8 PM until 1 AM the next morning.

Road closures associated with the event would occur from 8 AM on December 27, 2021 until 1 AM December 28, 2021 and would include 5th Ave between F Street & J Street and on Market Street between 4th Ave & 6th Ave. Parking will be removed on Island Ave between 4th Ave and 6th Ave. Anticipated total number of attendees is approximately 2400.

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: This action is exempt pursuant to CEQA Guidelines sections 15269(c), Emergency Project, and 15359, Emergency. This action is necessary to prevent or mitigate an emergency, and is also necessary to address a sudden and unexpected occurrence involving a clear and imminent danger, demanding immediate action to prevent or mitigate the loss of, or damage to, life, health, property, or essential public services related to the COVID-19 pandemic. This permit will allow the City to implement actions needed to prevent or

mitigate the adverse effects to public health, safety, and welfare related to the spread of COVID-19 by allowing the use of public spaces for COVID-19 safety and economic recovery. Specifically, the use of these public spaces is immediately necessary to ensure that restaurant and retail uses, which are critical to the City's economy, and therefore, have the ability to provide essential services, and have sufficient physical areas to ensure social distancing to prevent or mitigate the spread of COVID-19. If additional spaces cannot be made available for these uses, social distancing would be physically constrained, and could therefore, could result in the spread of COVID-19.

The appeal filing fee must be postmarked within 5 business days of the date the appeal is filed.
2. Appeals filed via US Mail: Send the appeal by US Mail to City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101. Appeals filed by US Mail must have a United States Postal Service (USPS) postmark by the appeal deadline to be considered valid. The [appeal application can be obtained here](#). You must separately mail the required appeal fee by check payable to the City Treasurer to: City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101. The appeal filing fee must be postmarked within 5 business days of the date the appeal is filed.
