NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

PLANNING DEPARTMENT

PROJECT NAME/NUMBER: Special Event Permit – Holiday Bowl 5K

COMMUNITY PLAN AREA: Downtown

COUNCIL DISTRICT: 3

LOCATION: North Harbor Drive and Embarcadero Walkways

PROJECT DESCRIPTION: Special Event Permit for that portion of a SK Run/Walk event that would occur within the City of San Diego's jurisdiction that would occur along Harbor Drive and the Embarcadero pathways on December 28, 2021. Noise associated with the event activities and set-up/dismantling would occur from 5 AM until 2 PM on December 28, 2021. Set-up would occur from 5 AM until 9 AM, the race would occur from 9:45 AM until 11:30 AM, and dismantling would occur from 11:00 AM until 2 PM.

The race route would begin on North Harbor Drive at Ash Street, head south in the SB lanes of North Harbor Drive, continue in the NB lanes of North Harbor Drive at Pacific Highway, turn right onto concrete walkway just past the Hyatt, turn left onto the boardwalk, turn around at the Hilton, turn left and circumnavigate Embarcadero-Marina Park North, and end at Ruocco Park. A road closure associated with the race would occur from 9 AM until 11:30 AM and includes North Harbor Drive between Pacific Coast Highway and the Hyatt Hotel. Sound amplification for the race would occur from 9 AM until 11:30 AM. The estimated number of attendees would be approximately 1000.

ENVIRONMENTAL DETERMINATION: CEQA exemptions §Section 15301 (Existing Facilities); §Section 15304(e) (Minor Alterations to Land); §Section 15311 (Accessory Structures); §Section 15323 (Normal Operations of Facilities for Public Gatherings).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: This action is exempt pursuant to CEQA Guidelines sections 15269(c), Emergency Project, and 15359, Emergency. This action is necessary to prevent or mitigate an emergency, and is also necessary to address a sudden and unexpected occurrence involving a clear and imminent danger, demanding immediate action to prevent or mitigate the loss of, or damage to, life, health, property, or essential public services related

to the COVID-19 pandemic. This permit will allow the City to implement actions needed to prevent or mitigate the adverse effects to public health, safety, and welfare related to the spread of COVID-19 by allowing the use of public spaces for COVID-19 safety and economic recovery. Specifically, the use of these public spaces is immediately necessary to ensure that restaurant and retail uses, which are critical to the City's economy, and therefore, have the ability to provide essential services, and have sufficient physical areas to ensure social distancing to prevent or mitigate the spread of COVID-19. If additional spaces cannot be made available for these uses, social distancing would be physically constrained, and could therefore, could result in the spread of COVID-19.

Applications to appeal CEQA determination to the City Council must be filed with the Office of the Clerk within 10 business days from the date of the posting of this Notice (**November 22, 2021**). During the Statewide "Safer-at-Home" directive to reduce the spread of COVID-19, beginning March 19, 2020, appeals to the City Clerk must be filed by email or US Mail as follows:

- 1. Appeals filed via E-mail: Send the appeal by email to Hearings1@sandiego.gov; your email appeal will be acknowledged within 24 hours. The application can be obtained here. You must separately mail the appeal fee by check payable to the City Treasurer to: City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101. The appeal filing fee must be postmarked within 5 business days of the date the appeal is filed.
- 2. Appeals filed via US Mail: Send the appeal by US Mail to City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101. Appeals filed by US Mail must have a United States Postal Service (USPS) postmark by the appeal deadline to be considered valid. The appeal application can be obtained here. You must separately mail the required appeal fee by check payable to the City Treasurer to: City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101. The appeal filing fee must be postmarked within 5 business days of the date the appeal is filed.
