INFORMATION & DISCUSSION ITEMS

1. Roundtable Discussion of Board's 2023 Work Plan
 - a. Member Landon – would like to have another “Day with a Disability” but perhaps can invite Council staff to pick a day, doesn't all have to be on the same day.
 - i. Member Sieglen-Perry reiterated importance of “Walk in their Shoes” event so City staff can have the experience.
 - b. Vice Chair Sieglen-Perry appreciates and wants continuation of projects being brought to Board for comments. Wants more of a presence and be in front of the Councilmembers.
 - c. Member Markoski stated that working on the budget PowerPoint gave her a lot of perspective and she'd like to be more involved and provide more activism in speaking and attending City Council meetings. She is very active and opinionated and is learning local government and would like to learn more. Ms. Curtis offered to have a special Accessibility Advisory Board meeting where she can teach group about how to find information on city's website and how to participate.
 - d. Jacqueline Jackson – uses MTS for transportation. MTS is changing their rules; previously users called and told operator when you needed to take a trip. Now MTS requires users to sign up for rides online, but in doing so they are negating and discriminating against the population who doesn't have computer access or computer skills. Additionally, she has done a lot with accessibility and training, has been a Windmills trainer. Windmills is a high-impact attitudinal training to learn and discuss thoughts and treatment of people with disabilities. Ms. Jackson is a proponent of this type of training for individuals as it affects change. Third, she's like business cards or badges so people recognize what organization she represents when she's at a meeting or in the community.
 - e. Victor Roosen would like data about people with disabilities in the city of San Diego. Ms. Curtis let him know that census data exists about where people with disabilities live in the City, as well as pedestrian propensity maps, transit corridor maps, and others. She will send those links out to the board.
