Community "Win" Monthly Highlights

A constituent reported a malfunctioning traffic signal which gave a pedestrian crossing signal and a right turn arrow at the same time. Kaitlyn Willoughby, my UC representative, worked with Traffic Engineering to resolve the issue in less than a week. Given its proximity to UCSD and residential areas, my staff worked quickly and efficiently to remedy the situation.





Ricky Flahive, my Carmel Valley representative, relentlessly

followed-up on an outstanding report of excessive brush in the northwestern corner of Elizabeth Rabbitt Park, resulting in its subsequent removal. Brush removal plays a key role in fire prevention and helps ensure the safety of nearby residents.

After residents raised concerns over traffic delays turning west on North Torrey Pines Road, we engaged City Traffic Engineering to evaluate the signal timing. City engineers subsequently adjusted the signal timing, resulting in an immediate and significant improvement in traffic flow.
