

## NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

PLANNING DEPARTMENT

PROJECT NAME: Special Event Permit - Hillcrest Farmers Market

COMMUNITY PLAN AREA: Uptown

**COUNCIL DISTRICT:** 3

**LOCATION:** Normal Street between Lincoln and University Avenues, Harvey Milk between Normal and Cleveland Streets

**PROJECT DESCRIPTION:** Special Event Permit for a weekly farmers' market that would include the temporary use of produce vendors, food vendors, merchandise vendors, food booths, entertainment, portable restrooms, canopies, tables, and chairs and that would occur on the west lane and median on Normal Street between Lincoln Avenue and University Avenue, and on Harvey Milk between Normal and Cleveland Streets every Sunday in 2022 starting on January 2, 2022. Noise associated with the event activities and set-up/dismantling would occur from 6 AM until 6 PM on each Sunday throughout the year. Set-up would occur from 6 AM until 9 AM, the market would occur from 9 AM until 2 PM, and clean-up/dismantling would occur from 2 PM to 6 PM. There would be musicians with low volume amplifiers for entertainment, and sound amplification during the event.

Road closures associated with the event would include the west lane and median on Normal Street between Lincoln and University Avenues, and Harvey Milk between Normal and Cleveland Streets, and would occur every Sunday from 6 AM until 6 PM. The DMV driveways would be closed along Normal Street.

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review and determined the project meets the categorical exemption criteria set forth in the CEQA State Guidelines: §Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; §Section 15304(e) (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; §Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; §Section 15323 (Normal Operations of Facilities for Public Gatherings) which allows for the normal operations of existing facilities for

public gatherings for which the facilities were designed, where there is a past history of the facility being used for the same or similar kind of purpose has been occurring for at least three years and that there is a reasonable expectation that the future occurrence of the project would not represent a change in the operation of the facility.

In addition, the exceptions set forth in the CEQA State Guidelines §15300.2 do not apply to this project wherein: a) the project would not impact an environmental resource of hazardous or critical concern where designated, precisely mapped, and officially adopted pursuant to law by federal, state, or local agencies; b) no cumulative impacts of successive projects of the same type in the same place were identified; c) there is no reasonable possibility that the project would have a significant effect on the environment due to unusual circumstances; d) the project would not result in damage to scenic resources, including but not limited to, trees, historic buildings, rock outcroppings, or similar resources, within a highway officially designated as a state scenic highway; e) the project is not located on a site which is included on any list compiled pursuant to Section 65962.5 of the Government Code; and f) the project would not cause a substantial adverse change in the significance of a historical resource.

Appeals filed by US Mail must have a United States Postal Service (USPS) postmark by the appeal deadline to be considered valid. The <u>appeal application can be obtained here</u>. The appeal filing fee must be postmarked within 5 business days of the date the appeal is filed.
