# **REVISED NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION**

## **PLANNING DEPARTMENT**

**PROJECT NAME:** Special Event Permit – 40th Annual Saint Patrick's Day Parade & Festival

**COMMUNITY PLAN AREA:** Balboa Park and Uptown

**COUNCIL DISTRICT:** 3

**LOCATION:** Fifth and Sixth Avenues and the western portion of Balboa Park

**PROJECT DESCRIPTION:** Special Event Permit for an annual parade and festival that would include the parade, a fenced-in beer garden, vendors, two stages, entertainment, music, sound amplification, portable restrooms, fencing and/or barriers, canopies, tables, and chairs that would occur along 5th Avenue, 6th Avenue, and the western portion of Balboa Park on March 12, 2022.

Noise associated with the event activities and set-up/dismantling would occur between 7 AM on March 11, 2022 and 12 PM on March 13, 2022. On March 11, 2022, set-up would occur from 7 AM until 8 PM, the event would occur from 7 AM to 8 PM on March 12, 2022 with the parade starting from 10:30 AM and ending at approximately 1 PM and then dismantling would occur from 7 AM to 12 PM on March 13, 2022. There would be stages with musical performances and sound amplification would occur from 10:30 AM until 6 PM on March 12, 2022. The beer garden would open at 1 PM through 6 PM on the day of the event.

On March 12, 2022, road closures associated with the event include 5<sup>th</sup> Avenue from Grape street to Upas Street from 9:30 AM to 1:30 PM, 6<sup>th</sup> Avenue from Grape Street to Laurel Ave and 6<sup>th</sup> Avenue from Quince St to Upas Street closed from 9:30 AM to 1:30 PM. The following streets would be closed from 9:30 AM to 6 PM; 6<sup>th</sup> Ave from Laurel St to Quince St, Balboa Ave from Juniper St to Upas St and El Prado from 6<sup>th</sup> Avenue to the bridge to Balboa Park. Traffic delays would be expected in all above mentioned streets starting at 6 AM on March 12, 2022.

**ENTITY MAKING ENVIRONMENTAL DETERMINATION:** City of San Diego Mayor-Appointed Designee

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review and determined the project meets the categorical exemption criteria set forth in the CEQA State Guidelines: §Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private

structures or facilities involving negligible or no expansion of use; §Section 15304(e) (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; §Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; §Section 15323 (Normal Operations of Facilities for Public Gatherings) which allows for the normal operations of existing facilities for public gatherings for which the facilities were designed, where there is a past history of the facility being used for the same or similar kind of purpose has been occurring for at least three years and that there is a reasonable expectation that the future occurrence of the project would not represent a change in the operation of the facility.

In addition, the exceptions set forth in the CEQA State Guidelines §15300.2 do not apply to this project wherein: a) the project would not impact an environmental resource of hazardous or critical concern where designated, precisely mapped, and officially adopted pursuant to law by federal, state, or local agencies; b) no cumulative impacts of successive projects of the same type in the same place were identified; c) there is no reasonable possibility that the project would have a significant effect on the environment due to unusual circumstances; d) the project would not result in damage to scenic resources, including but not limited to, trees, historic buildings, rock outcroppings, or similar resources, within a highway officially designated as a state scenic highway; e) the project is not located on a site which is included on any list compiled pursuant to Section 65962.5 of the Government Code; and f) the project would not cause a substantial adverse change in the significance of a historical resource.

Appeals filed by US Mail must have a United States Postal Service (USPS) postmark by the appeal deadline to be considered valid. The [appeal application can be obtained here](#).
