NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

PLANNING DEPARTMENT

PROJECT NAME/NUMBER: Special Event Permit – Boots in the Park

COMMUNITY PLAN AREA: Downtown

COUNCIL DISTRICT: 3

LOCATION: Harbor Drive, Access Road, Grape Street, County of San Diego Water Park at the Embarcadero

PROJECT DESCRIPTION: Special Event Permit for temporary lane, sidewalk, and road closures within San Diego that would be associated with a music festival that would occur at the County of San Diego Waterfront Park at the Embarcadero on April 2, 2022. The event permit would be issued by the County.

Public parking would be prohibited on Harbor Drive from West Ash Street to West Grape Street from March 30, 2022 at 3 PM through April 4, 2022 at 11 AM. Public parking would be prohibited on West Grape Street from Harbor Drive to Pacific Highway from March 31, 2022 at 7 AM through April 3, 2022 at 8 PM.

Road, lane and sidewalk closures would be associated with this event. Lane 3 along North Harbor Drive from Ash Street to Grape Street would be closed from March 31, 2022 at 7 AM through April 4, 2022 at 10 AM. The sidewalk along Harbor Drive between Hawthorn and Grape Streets would be closed from March 31, 2022 at 7 AM through April 3, 2022 at 10 AM. West Ash Street from Pacific Highway to Harbor Drive would be closed from 7 AM on April 2, 2022, until 2 AM on April 3, 2022. The access road on Harbor Drive between Hawthorne and Grape Streets would be closed from March 31, 2022 at 7 AM through April 4, 2022 at 8 AM.

Noise associated with the event activities and set-up/dismantling would occur from 3 PM on March 30, 2022, until 11 AM on April 4, 2022. Set up would occur over four days from March 30, 2022 through April 2, 2022. On March 30, 2022, set up would occur from 3 PM to 8 Pm, March 31, 2022 and April 1, 2022 from 7 AM to 8 PM and on April 2, 2022 from 7 AM to 2 PM. The event would occur on April 2, 2022 from 2 PM until 11 PM. Dismantling would occur over three days; April 2, 2022 from 11 PM until PM.11:55 PM, April 3, 2022 from 12 AM to 8 PM and on April 4, 2022 from 7 AM to 11 AM.

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review and determined the project meets the categorical exemption criteria set forth in the CEQA State Guidelines: §Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; §Section 15304(e) (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; §Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use.

In addition, the exceptions set forth in the CEQA State Guidelines §15300.2 do not apply to this project wherein: a) the project would not impact an environmental resource of hazardous or critical concern where designated, precisely mapped, and officially adopted pursuant to law by federal, state, or local agencies; b) no cumulative impacts of successive projects of the same type in the same place were identified; c) there is no reasonable possibility that the project would have a significant effect on the environment due to unusual circumstances; d) the project would not result in damage to scenic resources, including but not limited to, trees, historic buildings, rock outcroppings, or similar resources, within a highway officially designated as a state scenic highway; e) the project is not located on a site which is included on any list compiled pursuant to Section 65962.5 of the Government Code; and f) the project would not cause a substantial adverse change in the significance of a historical resource.

During the Statewide "Safer-at-Home" directive to reduce the spread of COVID-19, beginning March 19, 2021, appeals to the City Clerk must be filed by email or US Mail as follows:

- 1. Appeals filed via E-mail: Send the appeal by email to Hearings1@sandiego.gov; your email appeal will be acknowledged within 24 hours. The application can be obtained here. You must separately mail the appeal fee by check payable to the City Treasurer to: City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101. The appeal filing fee must be postmarked within 5 business days of the date the appeal is filed.
- 2. Appeals filed via US Mail: Send the appeal by US Mail to City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101. Appeals filed by US Mail must have a United States Postal Service (USPS) postmark by the appeal deadline to be considered valid. The appeal application can be obtained here. You must separately mail the required appeal fee by check payable to the City Treasurer to: City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101. The appeal filing fee must be postmarked within 5 business days of the date the appeal is filed.
