## **REVISED NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION**

PLANNING DEPARTMENT

PROJECT NAME: Special Event Permit - 2022 Race for Autism

**COMMUNITY PLAN AREA:** Balboa Park and Uptown **COUNCIL DISTRICT:** 3

**LOCATION:** Sixth Avenue, Laurel Street, Balboa Drive, El Prado, Pan American Way East, Pan American West, and the western portion of Balboa Park

**PROJECT DESCRIPTION:** Special Event Permit for a SK run/walk, a one-mile family walk, and a fair event that would include the temporary use of a stage, a DJ, games, resource fair activities, canopies, tables, and chairs, generators, sound amplification, portable restrooms, and recycling and trash containers that would occur in Balboa Park on April 2, 2022. Noise associated with the event activities and set-up/dismantling would occur from 11 AM on April 1, 2022 until 2 PM on April 2, 2022. Set-up would occur from 11 AM until 6 PM on April 1, 2022, the event would occur from 6:30 AM until 11 AM on April 2, 2022, and dismantling would occur from 11 AM until 2 PM on April 2, 2022. ADA parking will be available on 6<sup>th</sup> Ave between Maple St and Upas Street.

Road closures associated with the event would occur on April 2, 2022 between 6 AM to 9:30 AM on 6<sup>th</sup> Ave northbound between Hawthorn St and Upas Street, El Prado from 6<sup>th</sup> Ave to Pan American Rd E, Pan American Road E from El Prado to Pan American Rd West, Pan American Road West to Presidents Way, Pan American Road East to El Prado.

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review and determined the project meets the categorical exemption criteria set forth in the CEQA State Guidelines: §Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; §Section 15304(e) (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; §Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to,

temporary use items in publicly owned facilities or other facilities designated for public use; §Section 15323 (Normal Operations of Facilities for Public Gatherings) which allows for the normal operations of existing facilities for public gatherings for which the facilities were designed, where there is a past history of the facility being used for the same or similar kind of purpose has been occurring for at least three years and that there is a reasonable expectation that the future occurrence of the project would not represent a change in the operation of the facility.

In addition, the exceptions set forth in the CEQA State Guidelines §15300.2 do not apply to this project wherein: a) the project would not impact an environmental resource of hazardous or critical concern where designated, precisely mapped, and officially adopted pursuant to law by federal, state, or local agencies; b) no cumulative impacts of successive projects of the same type in the same place were identified; c) there is no reasonable possibility that the project would have a significant effect on the environment due to unusual circumstances; d) the project would not result in damage to scenic resources, including but not limited to, trees, historic buildings, rock outcroppings, or similar resources, within a highway officially designated as a state scenic highway; e) the project is not located on a site which is included on any list compiled pursuant to Section 65962.5 of the Government Code; and f) the project would not cause a substantial adverse change in the significance of a historical resource.

1. Appeals filed via E-mail: Send the appeal by email to <u>Hearings1@sandiego.gov</u>; your email appeal will be acknowledged within 24 hours. The <u>appeal application can be obtained here</u>. You must separately mail the appeal fee by check payable to the City Treasurer to: City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101. The appeal filing fee must be postmarked within 5 business days of the date the appeal is filed.

2. Appeals filed via US Mail: Send the appeal by US Mail to City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101. Appeals filed by US Mail must have a United States Postal Service (USPS) postmark by the appeal deadline to be considered valid. The <u>appeal application can be obtained here</u>. You must separately mail the required appeal fee by check payable to the City Treasurer to: City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101. The appeal filing fee must be postmarked within 5 business days of the date the appeal is filed.
