REVISED NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

PLANNING DEPARTMENT

PROJECT NAME: Special Event Permit – Earth Fair 2022

COMMUNITY PLAN AREA: Balboa Park

COUNCIL DISTRICT: 3

LOCATION: Balboa Park

PROJECT DESCRIPTION: Special Event Permit for an Earth Day celebration event that would include exhibitions, children's activities, a parade, entertainment, stages, generators, art, tents, canopies, electric vehicles and international food pavilion's, a fenced-in beer garden, and food vendors & food preparation that would occur in Balboa Park April 24, 2022. Noise associated with the event activities and set-up/dismantling would occur from 7 AM on April 22, 2022, to 11 AM on April 25, 2022. Set-up for the event would begin on April 22, 2022 from 7 AM to 5 PM, on April 23, 2022 from 7 AM to 5 PM and on April 24, 2022 from 5 AM to 10 PM, the event would occur on April 24, 2022 from 10 AM to 5 PM, and dismantling would occur on April 24, 2022 from 5 PM to 9 PM and on April 25, 2022 from 7 AM to 11 AM.

Road closures are as follows: April 24, 2022 from 9 AM to 5 PM on El Prado from Sefton Plaza to Pan American Road E, and on Village Place from El Prado to Park Blvd, and on Presidents Way from Pan American Road E to Park Blvd.

Parking would be removed on the following streets: April 24, 2022 from 4 AM to 5 PM on Village Place from Park Blvd to El Prado, and on Presidents Way from Park Blvd to Pan American Road East. Public parking would not be allowed at the following locations: on April 24, 2022 from 4 AM to 5 PM Pan American Plaza Parking Lot, Organ Pavilion north end of the parking lot. The south end of the Organ Pavilion parking lot would prohibit approximately 10 parking spaces from public parking from 4 AM to 12:05 PM on April 24, 2022.

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review and determined the project meets the categorical exemption criteria set forth in the CEQA State Guidelines: §Section 15301 (Existing Facilities) which allows for the operation,

repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; §Section 15304(e) (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; §Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; §Section 15323 (Normal Operations of Facilities for Public Gatherings) which allows for the normal operations of existing facilities for public gatherings for which the facilities were designed, where there is a past history of the facility being used for the same or similar kind of purpose has been occurring for at least three years and that there is a reasonable expectation that the future occurrence of the project would not represent a change in the operation of the facility.

In addition, the exceptions set forth in the CEQA State Guidelines §15300.2 do not apply to this project wherein: a) the project would not impact an environmental resource of hazardous or critical concern where designated, precisely mapped, and officially adopted pursuant to law by federal, state, or local agencies; b) no cumulative impacts of successive projects of the same type in the same place were identified; c) there is no reasonable possibility that the project would have a significant effect on the environment due to unusual circumstances; d) the project would not result in damage to scenic resources, including but not limited to, trees, historic buildings, rock outcroppings, or similar resources, within a highway officially designated as a state scenic highway; e) the project is not located on a site which is included on any list compiled pursuant to Section 65962.5 of the Government Code; and f) the project would not cause a substantial adverse change in the significance of a historical resource.

2. Appeals filed via US Mail: Send the appeal by US Mail to City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101. Appeals filed by US Mail must have a United States Postal Service (USPS) postmark by the appeal deadline to be considered valid. The [appeal application can be obtained here](#).
