NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

PROJECT NAME/NUMBER: Special Event Permit – Ragnar Relay SoCAl 2022

COMMUNITY PLAN AREAS: University City, Torrey Pines, Carmel Valley, La Jolla, Pacific Beach, Mission Beach, Mission Bay Park, Ocean Beach, Peninsula, Downtown, Clairemont, Mira Mesa, Scripps Ranch, Sabre Springs

COUNCIL DISTRICTS: 1, 2, 3, 5, 6

LOCATION: City streets from Torrey Pines to Downtown San Diego

PROJECT DESCRIPTION: Special Event Permit for the portion of the Ragnar Relay So Cal 2022 for an approximate 200 mile relay run event that would occur within the City of San Diego right-of-way jurisdiction on April 29 & 30, 2022. Noise associated with the event activities and set-up/dismantling would occur within the City of San Diego from 9 AM on April 28, 2022 until 5 AM on April 30, 2022. On April 28, 2022, set-up would occur from 9 AM until 9 PM, the event day 1 would occur from 5 AM until 11:55 PM on April 29, 2022 with dismantling occurring from 3 PM to 11:55 PM and event day 2 would occur on April 30, 2022 from 12 AM to 3:30 AM and dismantling would occur from 12 AM until 5 AM.

The attached maps indicate the City's portion of the run and the exchange points where the runners exchange the baton for the relay. Runners would use sidewalks and trails, and no road closures or traffic rerouting would occur with this event.

statement supporting reason for environmental determination: This action is exempt pursuant to CEQA Guidelines sections 15269(c), Emergency Project, and 15359, Emergency. This action is necessary to prevent or mitigate an emergency, and is also necessary to address a sudden and unexpected occurrence involving a clear and imminent danger, demanding immediate action to prevent or mitigate the loss of, or damage to, life, health, property, or essential public services related to the COVID-19 pandemic. This permit will allow the City to implement actions needed to prevent or mitigate the adverse effects to public health, safety, and welfare related to the spread of COVID-19 by allowing the use of public spaces for COVID-19 safety and economic recovery. Specifically, the use of these public spaces is immediately necessary to ensure that restaurant and retail uses, which are

critical to the City's economy, and therefore, have the ability to provide essential services, and have sufficient physical areas to ensure social distancing to prevent or mitigate the spread of COVID-19. If additional spaces cannot be made available for these uses, social distancing would be physically constrained, and could therefore, could result in the spread of COVID-19.

Applications to appeal CEQA determination to the City Council must be filed with the Office of the Clerk within 10 business days from the date of the posting of this Notice (**February 28, 2022**). During the Statewide "Safer-at-Home" directive to reduce the spread of COVID-19, beginning March 19, 2020, appeals to the City Clerk must be filed by email or US Mail as follows:

- Appeals filed via E-mail: Send the appeal by email to <u>Hearings1@sandiego.gov</u>; your email appeal will be acknowledged within 24 hours. The <u>appeal application can be obtained here</u>. You must separately mail the appeal fee by check payable to the City Treasurer to: City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101. The appeal filing fee must be postmarked within 5 business days of the date the appeal is filed.
- 2. Appeals filed via US Mail: Send the appeal by US Mail to City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101. Appeals filed by US Mail must have a United States Postal Service (USPS) postmark by the appeal deadline to be considered valid. The <u>appeal application can be obtained here</u>. You must separately mail the required appeal fee by check payable to the City Treasurer to: City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101. The appeal filing fee must be postmarked within 5 business days of the date the appeal is filed.




