NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

PROJECT NAME: Special Event Permit – SoCal Taco Fest

COMMUNITY PLAN AREA: Downtown **COUNCIL DISTRICT:** 3 **LOCATION:** Waterfront Park at 1600 Pacific Highway

PROJECT DESCRIPTION: Special Event Permit for temporary lane, sidewalk, and road closures within San Diego public right-of-way jurisdiction that would be associated with the SoCal Taco Fest, a taco festival, and 21-and-over event that would occur at the County of San Diego Waterfront Park at the Embarcadero on May 14, 2022. The event permit would be issued by the County.

Lane, parking, and sidewalk closures within the City's jurisdiction would occur from 6 AM on May 12, 2022, until 9 PM on May 15, 2022, and would include Harbor Drive – one northbound traffic lane, sidewalk, and parking along the eastern curb, between Ash Street and Grape Street; the access/frontage road on Harbor Drive between Hawthorne and Grape Streets would be closed from 5 AM on May 12, 2022 until 8 PM on May 15, 2022; Ash Street between Pacific Highway and Harbor Drive would be closed from 6 AM until 12 PM on May 14, 2022; from May 12, 2022 from 6 AM until 8 PM on May 15, 2022; de parking lane and the sidewalk of Grape Street between Harbor Drive and Pacific Highway, and the west parking lane (12 spaces) of Pacific Highway between Grape Street and Ash Street. See map attached. Noise associated with the event activities and set-up/ dismantling would occur from 6 AM on May 12, 2022, until 8 PM on May 15, 2022. There would be three stages with entertainment and sound amplification would occur from 12 PM until 10 PM on May 14, 2022. Set-up would occur from 6 AM until 8 PM on May 12, 2022, and from 6 AM until 10 PM on May 13, 2022. On May 14, 2022, the event would occur from 12 PM until 10 PM. On May 13, 2022. On

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego

conducted an environmental review and determined the project meets the categorical exemption criteria set forth in the CEQA State Guidelines: §Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; §Section 15304(e) (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; §Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use.

In addition, the exceptions set forth in the CEQA State Guidelines §15300.2 do not apply to this project wherein: a) the project would not impact an environmental resource of hazardous or critical concern where designated, precisely mapped, and officially adopted pursuant to law by federal, state, or local agencies; b) no cumulative impacts of successive projects of the same type in the same place were identified; c) there is no reasonable possibility that the project would have a significant effect on the environment due to unusual circumstances; d) the project would not result in damage to scenic resources, including but not limited to, trees, historic buildings, rock outcroppings, or similar resources, within a highway officially designated as a state scenic highway; e) the project is not located on a site which is included on any list compiled pursuant to Section 65962.5 of the Government Code; and f) the project would not cause a substantial adverse change in the significance of a historical resource.
