NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

PLANNING DEPARTMENT

PROJECT NAME: Special Event Permit – 33rd Annual LSU Alumni of San Diego Crawfish Boil

COMMUNITY PLAN AREA: Downtown

COUNCIL DISTRICT: 3

LOCATION: Harbor Drive, County of San Diego Water Park at the Embarcadero (1600 Pacific Hwy)

PROJECT DESCRIPTION: Special Event Permit for lane, sidewalk, and road closures within San Diego that would be associated with a one-day 21 and up festival that would occur at the County of San Diego Waterfront Park at the Embarcadero on May 21, 2022. Noise associated with the event activities and set-up/dismantling would occur from 8 AM on May 19, 2022, until 10:30 PM on May 21, 2022. There would be one stage with musical performances and sound amplification would occur from 12:15 PM until 5 PM on May 21, 2022. On May 19, 2022, set-up would occur from 8 AM until 5 PM. On May 20, 2022, set-up would occur from 7 AM until 5 PM. The event would occur from 10 AM until 5 PM on May 21, 2022, and dismantling would occur from 5:50 PM until 10:30 PM. Approximately 3,500 attendees are anticipated throughout the course of the event.

The event permit would be issued by the County. Lane/sidewalk closures would occur from 8:30 AM on May 19, 2022, until 10:30 PM on May 21, 2022, and would include one NB lane, the parking area, and the sidewalk on Harbor Drive between Ash and Grape.

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review and determined the project meets the categorical exemption criteria set forth in the CEQA State Guidelines: §Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; §Section 15304(e) (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; §Section 15311 (Accessory Structures) which allows for construction, or

placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use.

In addition, the exceptions set forth in the CEQA State Guidelines §15300.2 do not apply to this project wherein: a) the project would not impact an environmental resource of hazardous or critical concern where designated, precisely mapped, and officially adopted pursuant to law by federal, state, or local agencies; b) no cumulative impacts of successive projects of the same type in the same place were identified; c) there is no reasonable possibility that the project would have a significant effect on the environment due to unusual circumstances; d) the project would not result in damage to scenic resources, including but not limited to, trees, historic buildings, rock outcroppings, or similar resources, within a highway officially designated as a state scenic highway; e) the project is not located on a site which is included on any list compiled pursuant to Section 65962.5 of the Government Code; and f) the project would not cause a substantial adverse change in the significance of a historical resource.

Appeals filed by US Mail must have a United States Postal Service (USPS) postmark by the appeal deadline to be considered valid. The [appeal application can be obtained here](#). The appeal filing fee must be postmarked within 5 business days of the date the appeal is filed.
