NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

PROJECT NAME: Special Event Permit – Indian Wedding Baraat (Procession)
COMMUNITY PLAN AREA: La Jolla
COUNCIL DISTRICT: 1
LOCATION: 1132 Prospect St, La Jolla, CA 92037, Prospect Street, Girard Avenue

PROJECT DESCRIPTION: Special Event Permit for a parade/wedding procession event that would include the temporary use of a horse to occur in area within La Jolla on May 30, 2022. Noise associated with the event activities and set-up/dismantling would occur from 11:15 AM until 12:45 AM. On May 30, 2022 set-up would occur from 11:15 AM until 11:30 AM, the event would occur from 11:30 AM until 12:30 PM, and dismantling would occur from 12:30 PM until 12:45 AM. Approximately 100 attendees are anticipated throughout the course of the event.

Street closures would be associated with the event on May 30, 2022 and would include westbound Prospect Street between Ivanhoe Avenue and Girard Avenue from 10:45 AM until 12:45 PM, and Girard Avenue between Prospect Street and Coast Boulevard from 11 AM until 12:45 PM. Parking closures would be associated with the event on May 30, 2022 and would include Prospect Street between Ivanhoe Avenue and Girard Avenue from 11 AM until 12:45 PM, and Girard Avenue between Prospect Street and Coast Boulevard from 11 AM until 12:45 PM.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory

Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

- <u>Appeals filed via E-mail</u>: Send the appeal by email to <u>Hearings1@sandiego.gov</u>; your email appeal will be acknowledged within 24 hours. The <u>appeal application can be obtained here</u>. You must separately mail the appeal fee by check payable to the City Treasurer to: City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101. The appeal filing fee must be postmarked within 5 business days of the date the appeal is filed.
- 2. <u>Appeals filed In-Person:</u> The appeal application can be obtained in the Lobby of the City Administration Building located at 202 'C' Street, San Diego, CA 92101. The completed appeal package must include the required appeal fee in the form of a check payable to the City Treasurer to: **City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101.**
