NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

SPECIAL EVENTS DEPARTMENT

PROJECT NAME: Special Event Permit – Rock n' Roll San Diego 5K

COMMUNITY PLAN AREA: Balboa Park and Uptown

COUNCIL DISTRICT: 3

LOCATION: Balboa Park, Inspiration Point Parking lot, Marston Point parking lot, Presidents Way, El

Prado, 6th Avenue between Juniper and Upas

PROJECT DESCRIPTION: Special Event Permit for a 5K run event and festival in Balboa Park that would include the temporary use of the run route, a stage, portable restrooms, portable recycling/trash containers, tents/canopies, generator, a drone, entertainment, food trucks, fencing/berries, and beer garden that would occur on June 4, 2022. Noise associated with the event activities and set-up/dismantling would occur from 8 AM on June 3, 2022, until 12 PM on June 4, 2022. There would be one stage for announcements/entertainment, and sound amplification would occur at the finish area from 6 AM until 10 AM. Alcohol would be served from 7:15 AM until 9:30 AM on June 4, 2022. Set-up would occur from 8 AM until 4 PM on June 3, 2022. On June 4, 2022, the run would occur from 5 AM until 10 AM, and the event would be dismantled from 10 AM until 12 PM.

The course for the event would begin at Presidents Way and Park Boulevard. See map attached for complete route details.

Road closures would be associated with this event and would include eastbound include eastbound Presidents Way from Park Boulevard from 8 AM on Friday, June 3, 2022 until 9 AM on Saturday, June 4, 2022, Presidents Way between Park Boulevard and Pan American Road East from 6:30 AM until 8 AM on Saturday, June 4, 2022, Pan American Road East between Presidents Way and El Prado from 6:30 AM until 8 AM on Saturday, June 4, 2022, El Prado between Pan American Road East and 6th Avenue from 6:30 AM until 8 AM on Saturday, June 4, 2022, Balboa Drive between El Prado/Laurel Street and Marston Point from 5 AM until 8:30 AM on Saturday, June 4, 2022, Balboa Drive between Marston Point and Juniper Street from 5 AM until 8:30 AM on Saturday, June 4, 2022, Juniper Street between 6th Avenue and Balboa Drive from 5 AM until 8:30 AM on Saturday, June 4, 2022, Northbound 6th Avenue between Juniper Street and Balboa Drive from 5 AM until 9:30 AM on Saturday, June 4, 2022, Balboa Drive between Upas Street and Quince Drive from 5 AM until 9:30 AM on Saturday, June 4, 2022, Balboa Drive between Quince Drive and El Prado/Laurel Street from 8 AM on Friday, June 3, 2022 until 12 PM on Saturday, June 4, 2022. STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

- 1. Appeals filed via E-mail: Send the appeal by email to Hearings1@sandiego.gov; your email appeal will be acknowledged within 24 hours. The appeal application can be obtained here. You must separately mail the appeal fee by check payable to the City Treasurer to: City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101. The appeal filing fee must be postmarked within 5 business days of the date the appeal is filed.
- 2. <u>Appeals filed In-Person:</u> The appeal application can be obtained in the Lobby of the City Administration Building located at 202 'C' Street, San Diego, CA 92101. The completed appeal package must include the required appeal fee in the form of a check payable to the City Treasurer to: City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101.
