NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

PROJECT NAME: Special Event Permit – Café Tianguis **COMMUNITY PLAN AREA:** Mid-City: City Heights

COUNCIL DISTRICT: 9

LOCATION: 4011 46th Street, San Diego, CA 92105

PROJECT DESCRIPTION: Special Event Permit for a summer community block party that would include food vendors, food trucks, musicians/entertainment, artist, sound amplification, and with the temporary use of a stage, canopies, tents, generators, tables, chairs, that would occur on 4011 46th Street in City Heights on June 25, 2022. Noise associated with the event activities and set-up/dismantling would occur from 6:30 AM until 7 PM on June 25, 2022. A stage would be used for entertainment, and sound amplification would occur from 9 AM until 5 PM on June 25, 2022. Set-up would occur from 6:30 AM until 9 AM, the event would occur from 9 AM until 5 PM, and clean-up/dismantling would occur from 5 PM until 7 PM on June 25, 2022. Approximately 500 attendees are anticipated to attend this event.

A road closure and associated with this event would occur on NB and SB lanes of 46th Avenue between University Avenue and Polk Avenue from 6 AM until 7 PM. Residents only would be permitted.

Parking closures would be associated with this event and would occur on both sides of 46th Avenue between University Avenue and 4011 46th Street from 6 AM until 7 PM.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing,

licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

- 1. Appeals filed via E-mail: Send the appeal by email to Hearings1@sandiego.gov; your email appeal will be acknowledged within 24 hours. The appeal application can be obtained here. You must separately mail the appeal fee by check payable to the City Treasurer to: City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101. The appeal filing fee must be postmarked within 5 business days of the date the appeal is filed.
- 2. <u>Appeals filed In-Person:</u> The appeal application can be obtained in the Lobby of the City Administration Building located at 202 'C' Street, San Diego, CA 92101. The completed appeal package must include the required appeal fee in the form of a check payable to the City Treasurer to: City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101.
