## NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

## **SPECIAL EVENTS DEPARTMENT**

PROJECT NAME: Special Event Permit - PQ 5K Community Fun Run/Walk 2022

**COMMUNITY PLAN AREA:** Rancho Penasquitos

**COUNCIL DISTRICT: 5** 

LOCATION: Black Mountain Road, SR-56 Bike Trail, and Camino del Sur in Rancho Penasquitos

**PROJECT DESCRIPTION:** Special Event Permit for a 5K fun run event that would occur on sidewalks in Rancho Penasquitos on June 25, 2022. Noise associated with the event activities and set-up/dismantling would occur from 6 AM until 12 PM on June 25, 2022. On June 25, 2022, set-up would occur from 6 AM until 6 AM, the event would occur from 7:30 AM until 12 PM, and the event would be dismantled from 11 AM until 12 PM. A public announcement system would be used to announce the race and sound amplification would occur at the starting line from 7 AM until 11 AM on June 25, 2022.

The fun run route would include a start in the parking lot at 12835 Black Mountain Road, turn right onto Black Mountain Road, turn left onto the SR-56 Bike Trail, turn right onto Camino del Sur, and finish at 14191 Camino del Sur in the parking lot, where a free breakfast would occur.

Participants would stay on the sidewalks would be positioned to each intersection, and no road closures would be associated with this event. See route map attached.

**ENTITY CONSIDERING PROJECT APPROVAL:** City of San Diego

**ENVIRONMENTAL DETERMINATION:** Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use

of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

Applications to appeal CEQA determination to the City Council must be filed with the Office of the Clerk within 5 business days from the date of the posting of this Notice (June 15, 2022). During the Statewide "Safer-at-Home" directive to reduce the spread of COVID-19, beginning March 19, 2021, appeals to the City Clerk must be filed by email or US Mail as follows:

- 1. Appeals filed via E-mail: Send the appeal by email to Hearings1@sandiego.gov; your email appeal will be acknowledged within 24 hours. The appeal application can be obtained here. You must separately mail the appeal fee by check payable to the City Treasurer to: City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101. The appeal filing fee must be postmarked within 5 business days of the date the appeal is filed.
- 2. <u>Appeals filed In-Person:</u> The appeal application can be obtained in the Lobby of the City Administration Building located at 202 'C' Street, San Diego, CA 92101. The completed appeal package must include the required appeal fee in the form of a check payable to the City Treasurer to: City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101.
