NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

SPECIAL EVENTS DEPARTMENT

PROJECT NAME: Park Use Permit – Sesame Street Comic-Con Activation COMMUNITY PLAN AREA: Downtown COUNCIL DISTRICT: 3 LOCATION: MLK Promenade

PROJECT DESCRIPTION: Approval of a Park Use Permit (PUP) to allow that portion of an activation event within the City's jurisdiction use of City-owned property in the grassy area of MLK Promenade south of 6th Avenue near the Omni Hotel in Downtown on July 21-24, 2022. This permit would allow the event to occur within the park area and would allow for the temporary use of a generator, inflatables, and inflatable barrier, a tv, speakers, sound amplification, and a step and repeat. Sound amplification would take place from 10 AM until 7 PM July 21-24, 2022. Noise associated with the event activities and set-up/dismantling would occur from 12 PM on July 20, 2022, until 5 PM on July 24, 2022. On July 20, 2022, set-up would occur from 12 PM until 5 PM. The event would occur from 10 AM until 7 PM until 7 PM until 5 PM on July 24, 2022. Approximately 2,500 attendees are anticipated during the course of the event. There would be no street or parking closures associated with this event.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in

publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

The <u>appeal application can be obtained here</u>. You must separately mail the appeal fee by check payable to the City Treasurer to: City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101. The appeal filing fee must be postmarked within 5 business days of the date the appeal is filed.
- 2. <u>Appeals filed In-Person</u>: The appeal application can be obtained in the Lobby of the City Administration Building located at 202 'C' Street, San Diego, CA 92101. The completed appeal package must include the required appeal fee in the form of a check payable to the City Treasurer to: **City Clerk/Appeal**, **MS 2A**, **202 C Street**, **San Diego**, **CA 92101**.
