## NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

SPECIAL EVENTS DEPARTMENT

PROJECT NAME: Special Event Permit – 2nd Annual Filipino American Friendship Festival
COMMUNITY PLAN AREA: Peninsula
COUNCIL DISTRICT: 2
LOCATION: NTC Park Liberty Station

**PROJECT DESCRIPTION:** Special Event Permit for a festival that would include cultural performances, art, food vendors, food trucks, health, and community booths, and children's activities and the temporary use of a stage, tents/canopies, generators, fencing and/or barriers, tables and chairs, portable restrooms, trash and recycling containers, on July 30, 2022 at Lot B and D at NTC Park in Liberty Station. Noise associated with the event activities and set-up/dismantling would occur between 12 PM and July 29, 2022 until 11:55 PM on July 30, 2022. There would be a stage with entertainment performances and sound amplification would occur from 10 AM until 6 PM. Setup would occur from 12 PM until 6 PM on July 29, 2022 and on July 30, 2022 from 8 AM to 11 AM. On July 30, 2022, the event would occur from 11 AM until 6 PM and dismantling would occur 6 PM until 11:55 PM. Parking lot closure would include thirty (30) parking spaces from parking lot D from 12 PM on July 30, 2022.

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in

publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

- <u>Appeals filed via E-mail</u>: Send the appeal by email to <u>Hearings1@sandiego.gov</u>; your email appeal will be acknowledged within 24 hours. The <u>appeal application can be obtained here</u>. You must separately mail the appeal fee by check payable to the City Treasurer to: City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101. The appeal filing fee must be postmarked within 5 business days of the date the appeal is filed.
- <u>Appeals filed In-Person</u>: The appeal application can be obtained in the Lobby of the City Administration Building located at 202 'C' Street, San Diego, CA 92101. The completed appeal package must include the required appeal fee in the form of a check payable to the City Treasurer to: City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101.
