NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

SPECIAL EVENTS DEPARTMENT

PROJECT NAME: Special Event Permit – Gaslamp 5K/10K

COMMUNITY PLAN AREA: Downtown

COUNCIL DISTRICT: 3

LOCATION: Fifth Avenue, 199 Fifth Ave, San Diego, CA 92101

PROJECT DESCRIPTION: Special Event Permit for a 5K/10K Run/Walk event that would include the race routes, a fenced-in beer garden, pre-packaged food, entertainment, and the temporary use of a stage, tents, temporary structures, generators, fencing and/or barriers, portable restrooms, and trash and recycling containers on July 31, 2022 and would occur in Downtown on Fifth Avenue. Alcohol would be served from 8:15 AM until 10 AM. Noise associated with the event activities and set-up/dismantling would occur from 4 AM until 11 AM on July 31, 2022. A sound system would be used for announcements/entertainment and sound amplification would occur at start and finish lines from 6:30 AM until 10 AM on July 31, 2022. On July 31, 2022, set-up would occur from 4 AM until 8 AM, the event would occur from 8 AM until 10 AM, and dismantling would occur from 10 AM until 11 AM. The estimated number of attendees would be approximately 1,200. See race course route details attached.

On July 31, 2022, road closures associated with the race would include:

5th Avenue between J Street and L Street from 7:30 AM until 11 AM; K Street between 3rd Avenue and 6th Avenue from 7:30 AM until 10 AM; 1st Avenue between J Street and Broadway from 7:30 AM until 10 AM; Broadway eastbound partial lane closure closed between 1st and 6th Avenue from 7:30 AM until 10 AM; 6th Avenue between Broadway and K Street from 7:30 AM until 10 AM;

On July 31, 2022, parking closures associated with the race would occur from 5 AM until 11 AM and includes: 5th Avenue between J Street and L Street; K Street between 3rd Avenue and 6th Avenue; 1st Avenue between J Street and Broadway; 6th Avenue between Broadway and K Street

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

The appeal filing fee must be postmarked within 5 business days of the date the appeal is filed.
2. Appeals filed In-Person: The appeal application can be obtained in the Lobby of the City Administration Building located at 202 'C' Street, San Diego, CA 92101. The completed appeal package must include the required appeal fee in the form of a check payable to the City Treasurer to: **City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101**.
