NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

SPECIAL EVENTS DEPARTMENT

PROJECT NAME: Special Event Permit – Transplant Games Bike

COMMUNITY PLAN AREA: Downtown

COUNCIL DISTRICT: 3

LOCATION: Harbor Drive, Park Boulevard, 200 Marina Park Way, San Diego, CA 92101

PROJECT DESCRIPTION:

Special Event Permit for that portion of a bike race event that would occur within the City of San Diego's jurisdiction that would occur along Harbor Drive between Park Boulevard and 32nd Street on July 31, 2022. There would be the temporary use of tents, generators, tables, chairs, portable restrooms, and trash and recycling containers. Noise associated with the event activities and set-up/dismantling would occur from 4 AM until 10 AM on July 31, 2022. Set-up would occur from 4 AM until 7 AM, the race would occur from 7 AM until 9 AM, and dismantling would occur from 9 AM until 10 AM. The estimated number of attendees would be approximately 200. The race route would begin at the exit to the Hilton Hotel on Park Boulevard and Gull Street, head east to Harbor Drive, turn right heading south in the #2 lane of Harbor Drive, then turn around at the base entrance of Surface Navy Boulevard (prior to 32 Street), then head North in the S/B #1 lane, turn left onto Park Boulevard and finish at Gull Street.

A road closure associated with the race would occur from 7:30 AM until 11 AM on July 31, 2022 and includes southbound lane of North Harbor Drive between Park Boulevard and 32nd Street. There would be no parking on North Harbor Drive between Park Boulevard and 32nd Street from 5 AM until 12 PM on July 31, 2022.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section

15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

During the Statewide "Safer-at-Home" directive to reduce the spread of COVID-19, beginning March 19, 2021, appeals to the City Clerk must be filed by email or US Mail as follows:

1. Appeals filed via E-mail: Send the appeal by email to Hearings1@sandiego.gov; your email appeal will be acknowledged within 24 hours. The [appeal application can be obtained here](#). You must separately mail the appeal fee by check payable to the City Treasurer to: **City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101**. The appeal filing fee must be postmarked within 5 business days of the date the appeal is filed.
2. Appeals filed In-Person: The appeal application can be obtained in the Lobby of the City Administration Building located at 202 'C' Street, San Diego, CA 92101. The completed appeal package must include the required appeal fee in the form of a check payable to the City Treasurer to: **City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101**.
