# **NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION**

## **SPECIAL EVENTS DEPARTMENT**

**PROJECT NAME:** Special Use Permit- BeerX 2022

**COMMUNITY PLAN AREA:** Downtown

**COUNCIL DISTRICT:** 3

**LOCATION:** Waterfront Park

**PROJECT DESCRIPTION:** Special Use Permit for the portion within the City's jurisdiction for a BeerX 2022, a craft beer and music festival on August 20, 2022 at the Waterfront Park. The event would include the temporary use of tents/canopies, three stages, live performances, generators, sound amplification, fencing and/or barriers, tables, chairs, alcohol, and onsite food preparation. Noise associated with the event activities and set-up/dismantling would occur on August 18, 2022 at 6 AM to August 21, 2022 at 8 PM. Set-up would be on August 18, 2022 from 6 AM to 8 PM and on August 19, 2022 from 6 AM to 8 PM. The event would occur on August 20, 2022 from 1 PM to 10 PM and dismantling would occur on August 21, 2022 from 6 AM to 8 PM. Anticipated number of attendees is approximately 4000 throughout the day of the event.

Road closures associated with the event would be on Harbor Drive from Ash Street to Grape Street northbound including the east curb parking from August 18, 2022 at 6 AM through August 21, 2022 at 8 PM, and the frontage road along Harbor Drive from Hawthorne to Grape Street in the southbound direction from August 18, 2022 at 5 AM through August 21, 2022 at 8 PM. Parking closures would occur on the south curb of Grape Street from Harbor Drive to Pacific Highway from August 18, 2022 at 6 AM through August 21, 2022 at 8 PM, and on Pacific Highway along the park from Grape Street to Ash Street on August 18, 2022 at 6 AM through August 20, 2022 at 11:55PM.

**ENTITY CONSIDERING PROJECT APPROVAL:** City of San Diego

**ENVIRONMENTAL DETERMINATION:** Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

**ENTITY MAKING ENVIRONMENTAL DETERMINATION:** City of San Diego Mayor-Appointed Designee

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

Applications to appeal CEQA determination to the City Council must be filed with the Office of the Clerk within 10 business days from the date of the posting of this Notice (August 5, 2022). During the Statewide "Safer-at-Home" directive to reduce the spread of COVID-19, beginning March 19, 2021, appeals to the City Clerk must be filed by email or US Mail as follows:

The appeal filing fee must be postmarked within 5 business days of the date the appeal is filed.

The completed appeal package must include the required appeal fee in the form of a check payable to the City Treasurer to: **City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101**.
