

Date of Notice: July 25, 2022 NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

PROJECT NAME: Special Use Permit- Jack Henry
COMMUNITY PLAN AREA: Downtown
COUNCIL DISTRICT: 3
LOCATION: 5th Ave between J and L, K Street between 4th Ave and 6th Ave

PROJECT DESCRIPTION: Special Use Permit for a private corporate block party event on September 1, 2022 on 4th Ave and 5th Ave Downtown San Diego. The event would include the temporary use of stages, music, performances, sound amplification, generators, tents/canopies, fencing and/or barriers, tables, chairs, alcohol, food preparation, portable restrooms, and recycle and trash containers. Anticipated number of attendees would be approximately 2000. Noise associated with the event activities and set-up/dismantling would occur from September 1, 2022 at 6 AM to September 2, 2022 at 6 AM. Set-up would occur on September 1, 2022 from 6 AM to 6:30 PM, the event would occur from 6:30 PM to 10 PM and dismantling occur from 10 PM to 12 PM on September 1, 2022 and continue on September 2, 2022 from 12 AM to 6 AM.

Road closures associated with this event would occur from September 1, 2022 at 6 AM through September 2, 2022 at 6 AM and would include K Street from 4th Ave and 6th Ave and 5th Ave from J and L. Parking would be closed on 6th Ave (west side) from J St to K St and on J Street from 4th Ave to 6th Ave during the same days and times as the road closures.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego

conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

The appeal filing fee must be postmarked within 5 business days of the date the appeal is filed.
- 2. <u>Appeals filed In-Person:</u> The appeal application can be obtained in the Lobby of the City Administration Building located at 202 'C' Street, San Diego, CA 92101. The completed appeal package must include the required appeal fee in the form of a check payable to the City Treasurer to: **City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101.**
