## NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

## **SPECIAL EVENTS DEPARTMENT**

PROJECT NAME: Special Event Permit - Live Well San Diego SK

**COMMUNITY PLAN AREA:** Downtown

**COUNCIL DISTRICT: 3** 

**LOCATION:** County Waterfront Park, Pacific Highway, Harbor Drive

**PROJECT DESCRIPTION:** Special Event Permit for that portion of a 5K run and festival event that would occur within the City's right-of-way jurisdiction on September 18, 2022. The festival would occur on Waterfront Park and would include vendors, children activities, and entertainment, a stage, entertainment, inflatables, sponsor booths, a food court, and the temporary use of portable restrooms, canopies, tables, and chairs. A sound system would be used for race announcements/entertainment and sound amplification would occur. The permit for the event activity within the Waterfront Park would be issued by the County. Noise associated with the event activities and set-up/dismantling would occur from September 17, 2022 at 3:30 PM to September 18, 2022 at 4:30 PM. Setup would occur on September 17, 2022 from 3:30 PM to 7:30 PM and on September 18, 2022 from 5 AM to 7 AM, The event would occur on September 18, 2022 from 7:30 AM to 11:30 AM and dismantling would occur from 11:30 AM to 4:30 PM. The run route is shown in the attached map.

Road closures would be associated with this event on September 18, 2022 from 5 AM to 11:30 AM and would include the following: Harbor Drive between W. Grape & Pacific Hwy, Pacific Hwy (southbound) between W. Grape and W. Harbor Dr, Ash Street between N. Harbor Dr and Pacific Hwy, and Broadway between N. Harbor Dr and Pacific Hwy. Street parking closures would occur on September 18, 2022 from 4 AM to 12 PM on the following streets: Harbor Dr (both sides) between W. Grape St and Pacific Hwy, Pacific Hwy (west side) between W. Grape St and W. Harbor, Ash Street (both sides) between N. Harbor Dr and Pacific Hwy.

**ENTITY CONSIDERING PROJECT APPROVAL:** City of San Diego

**ENVIRONMENTAL DETERMINATION:** Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311

(Accessory Structures).

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

During the Statewide "Safer-at-Home" directive to reduce the spread of COVID-19, beginning March 19, 2021, appeals to the City Clerk must be filed by email or US Mail as follows:

- 1. Appeals filed via E-mail: Send the appeal by email to Hearings1@sandiego.gov; your email appeal will be acknowledged within 24 hours. The appeal application can be obtained here. You must separately mail the appeal fee by check payable to the City Treasurer to: City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101. The appeal filing fee must be postmarked within 5 business days of the date the appeal is filed.
- 2. <u>Appeals filed In-Person:</u> The appeal application can be obtained in the Lobby of the City Administration Building located at 202 'C' Street, San Diego, CA 92101. The completed appeal package must include the required appeal fee in the form of a check payable to the City Treasurer to: City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101.

## 5K ROUTE SUNDAY, SEPT 18, 2022

@7:30am

TURN-BY-TURN ROUTE DESCRIPTION

- Race begins and proceeds south on Harbor Drive in the north bound lanes)
- 5K RACE START: 7:30am; (Kids 1-Mile Fun Run START: 8:30am)
- Right turn (west) onto boardwalk at Broadway Pier
- Cross lot entrance at Tuna Harbor. Continue on boardwalk toward Seaport Village
- 4) Right turn (south) into Embarcadero Park North
- 5) Continue through Embarcadero Park North back toward Seaport Village
- 6) Left turn at boardwalk (west) at northern point of Embarcadero Park North headed back toward Ruocco Park
- 7) Right turn at northern point of Ruocco Park (east) headed toward Pacific Highway and Harbor Drive
- Head north on Pacific Highway in the western side of the southbound traffic lanes
- 9) Continue north on Pacific Highway toward Waterfront Park
- 10) At SD County building at Waterfront Park, route turns onto sidewalk still headed north toward Grape Street
- 11) Left turn (west) around Waterfront Park on sidewalk at Grape Street
- 12) Left turn (south) continuing along sidewalk southbound
- Just past County building, left turn (east) into Waterfront Park on the sidewalk north of the Expo Area
- 14) Race finishes on the grass in the middle of the south quadrant of Waterfront Park in the Expo Area.
