

Date of Notice: August 17, 2022 NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

PROJECT NAME: Special Event Permit – CRSSD Music Festival COMMUNITY PLAN AREA: Downtown COUNCIL DISTRICT: 3

LOCATION: Harbor Drive, frontage Road along Harbor Drive, Grape Street, Pacific Highway, Ash Street, County of San Diego Water Park at the Embarcadero

PROJECT DESCRIPTION: Special Event Permit for lane, sidewalk, and road closures within the City of San Diego's right-of-way jurisdiction that would be associated with a two day music festival that would occur at the County of San Diego Waterfront Park at the Embarcadero on September 24 & 25, 2022. The event permit would be issued by the County. There would be three stages with musical performances and sound amplification during the event. Noise associated with the event activities and set-up/dismantling would occur from September 19, 2022 at 5 PM to September 27, 2022 at 8 AM. Set-up would occur over four days; on September 19, 2022 from 5 PM to 11 PM, September 20, 2022 from 6 AM to 11 PM, September 21, 2022 from 6 AM to 11 PM. The event days would be on September 24, 2022 from 12 PM to 11 PM and on September 25, 2022 from 12 PM to 10 PM. Road closures associated with the event include Ash Street from Pacific Highway to Harbor Drive from September 24, 2022 at 6 AM to September 25, 2022 at 11:59 PM. Harbor Dr easterly travel lane, parking and sidewalk from Ash Street to Grape Street from September 20, 2022 at 6 AM to September 27, 2022 at 8 AM, the frontage road along Harbor Drive from Grape Street to W. Hawthorn St from September 20, 2022 at 6 AM to September 26, 2022 at 8 PM,

Public parking would be prohibited on Pacific Highway from Ash St to Grape St, on Grape Street east of Harbor Drive along the south curb, and along the frontage road located east of Harbor Drive between Grape Street and Hawthorn Street from September 19, 2022 at 4 PM to September 26, 2022 at 8 PM.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

The appeal filing fee must be postmarked within 5 business days of the date the appeal is filed.
- 2. <u>Appeals filed In-Person:</u> The appeal application can be obtained in the Lobby of the City Administration Building located at 202 'C' Street, San Diego, CA 92101. The completed appeal package must include the required appeal fee in the form of a check payable to the City Treasurer to: **City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101.**
