# **NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION**

**PROJECT NAME/NUMBER:** Special Event Permit - Del Sur Fall Festival

**COMMUNITY PLAN AREA:** Black Mountain Ranch

**COUNCIL DISTRICT:** 5

**LOCATION:** 16112 Paseo Del Sur

**PROJECT DESCRIPTION:** Special Event Permit for that portion within the City's right-of-way jurisdiction of an event for the Del Sur Fall Festival located at 1611 Paseo Del Sur in Black Mountain Ranch on September 30, 2022. The event would include the temporary use of tables, chairs, canopies, portable restrooms, games, petting zoo area, food trucks, a beer garden, a generator, entertainment, and sound amplification.

Noise associated with the event activities and set-up/dismantling would occur from 3 PM on September 30, 2022 until 9:00 PM on October 2, 2022. Set-up would occur on September 30, 2022 from 3 PM to 5 PM, the event would occur from 5 PM to 10 PM and dismantling would occur on October 2, 2022 from 6 PM to 9 PM.

A road closure associated with the event would include Paseo Del Sur between the two Potomac Ridge Road intersections from 4 PM on September 30, 2022, until 9:00 PM on October 2, 2022.

**ENTITY CONSIDERING PROJECT APPROVAL:** City of San Diego

**ENVIRONMENTAL DETERMINATION:** Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

**ENTITY MAKING ENVIRONMENTAL DETERMINATION:** City of San Diego Mayor-Appointed Designee

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section

15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

Applications to appeal CEQA determination to the City Council must be filed with the Office of the Clerk within 5 business days from the date of the posting of this Notice (**August 29, 2022**). During the Statewide "Safer-at-Home" directive to reduce the spread of COVID-19, beginning March 19, 2021, appeals to the City Clerk must be filed by email or US Mail as follows:

The completed appeal package must include the required appeal fee in the form of a check payable to the City Treasurer to: **City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101**.
