NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

SPECIAL EVENTS DEPARTMENT

PROJECT NAME: Special Event Permit- Pacific Beachfest

COMMUNITY PLAN AREA: Pacific Beach

COUNCIL DISTRICT: 2

LOCATION: Pacific Beach Boardwalk, the Beach and local streets west of Mission Boulevard

PROJECT DESCRIPTION: Special Event Permit for the Pacific Beachfest along the Pacific Beach Boardwalk to Mission Blvd from Felspar St to Thomas Ave October 1, 2022. The event would include the temporary use of alcohol sales within a fenced in area, onsite food preparation & food tastings, food vendors, stages, sound amplification, generators, performances, music, arts and crafts, beach run, beach tennis, beach volleyball, surf contest, kids' area & activities, inflatable slide, jumpy houses, canopies, tables, chairs, fences and/or barriers, and portable restrooms. Noise associated with the event activities and set-up/dismantling would occur from 6 AM on September 30, 2022, until 12 PM on October 3, 2022. Set-up would occur on September 30, 2022 from 6 AM to 11:55 PM, the event would occur on October 1, 2022 from 11 AM to 7 PM and dismantling would occur on October 1, 2022 from 7 PM to 12 AM, and October 3, 2022 from 7 AM to 12 PM. Anticipated total number of attendees would be approximately 5000.

Road closures associated with the event would occur from 7 AM until 12 Midnight from September 30, 2022 through October 1, 2022 would include Thomas Avenue between Mission Boulevard and the Boardwalk, Grand Avenue between Mission Boulevard and the Boardwalk, Hornblend Street between Mission Boulevard and the Boardwalk, Garnet Avenue between Mission Boulevard and the Boardwalk, Felspar Street between Mission Boulevard and the Boardwalk and Ocean Blvd between Garnet Ave and Thomas Ave.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

Applications to appeal CEQA determination to the City Council must be filed with the Office of the Clerk within 10 business days from the date of the posting of this Notice (**September 14, 2022**). During the Statewide "Safer-at-Home" directive to reduce the spread of COVID-19, beginning March 19, 2021, appeals to the City Clerk must be filed by email or US Mail as follows:

The appeal filing fee must be postmarked within 5 business days of the date the appeal is filed.
2. Appeals filed In-Person: The appeal application can be obtained in the Lobby of the City Administration Building located at 202 'C' Street, San Diego, CA 92101. The completed appeal package must include the required appeal fee in the form of a check payable to the City Treasurer to: **City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101**.
