# **NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION**

**PROJECT NAME:** Special Event Permit- Talmadge Block Party

**COMMUNITY PLAN AREA:** Talmadge

**COUNCIL DISTRICT:** 9

**LOCATION:** 4600 Block of Adams Ave, Miracle Drive and Euclid Ave intersection and approaches

**PROJECT DESCRIPTION:** Special Event Permit for the Talmadge Block Party on October 8, 2022 at the intersection and it's approaches of Adams Ave, Miracle Drive and Euclid Ave. The event would include tables, chairs, canopies, carnival games, jumpy houses, food vendors, a stage and entertainment, music, sound amplification, generators, onsite food preparation, portable restrooms and recycle and trash containers (see attached map for location and activities). Noise associated with the event activities and set-up/dismantling would occur on October 8, 2022 from 7 AM to 8 PM. Set-up would occur from 7 AM to 3 PM, the event would occur from 3 PM to 7 PM and dismantling would occur from 7 PM to 8 PM. The total number of attendees is estimated to be approximately 400.

Road closures associated with the event would occur on October 8, 2022 from 10 AM to 8 PM within the limits of the event (see attachment) and would include 4600 block of Euclid Ave at the intersection with Adams Ave and Miracle Drive from Adams Ave and Miracle Drive.

**ENTITY CONSIDERING PROJECT APPROVAL:** City of San Diego

**ENVIRONMENTAL DETERMINATION:** Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

**ENTITY MAKING ENVIRONMENTAL DETERMINATION:** City of San Diego Mayor-Appointed Designee

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing,

licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

Applications to appeal CEQA determination to the City Council must be filed with the Office of the Clerk within 5 business days from the date of the posting of this Notice (**September 13, 2022**). During the Statewide "Safer-at-Home" directive to reduce the spread of COVID-19, beginning March 19, 2021, appeals to the City Clerk must be filed by email or US Mail as follows:

The appeal filing fee must be postmarked within 5 business days of the date the appeal is filed.
2. Appeals filed In-Person: The appeal application can be obtained in the Lobby of the City Administration Building located at 202 'C' Street, San Diego, CA 92101. The completed appeal package must include the required appeal fee in the form of a check payable to the City Treasurer to: **City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101**.
