

Date of Notice: October 24, 2022 NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

PROJECT NAME/NUMBER: Special Event Permit – 15th Annual Bike the Coast Bike Tour

COMMUNITY PLAN AREAS: Torrey Pines, Carmel Valley COUNCIL DISTRICT: 1

LOCATION: Carmel Valley Road at Pacific Coast Highway, Sorrento Valley Road, Carmel Mountain Road, El Camino Real, and Via De La Valle

PROJECT DESCRIPTION: Special Event Permit for that portion of the 15th Annual Bike the Coast Bike Tour event that would occur within the City of San Diego's jurisdiction on November 5, 2022. The bicycle ride begins and ends in another jurisdiction and makes use of some community roadways within the northwestern portion of San Diego. Noise associated with the entire event would occur from 4 AM until 5:30 PM on November 5, 2022.

Riders would enter the City of San Diego on Carmel Valley Road at Pacific Coast Highway, head east, turn right onto Sorrento Valley Road, u-turn near Performance Bicycle, turn right onto Carmel Mountain Road, turn left onto El Camino Real, turn left onto Via De La Valle, and leave the City to complete the ride in other jurisdictions. No road closures would occur with this event, and all riders will abide by rules of the road.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section

15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

During the Statewide "Safer-at-Home" directive to reduce the spread of COVID-19, beginning March 19, 2021, appeals to the City Clerk must be filed by email or US Mail as follows:

The appeal filing fee must be postmarked within 5 business days of the date the appeal is filed.
- 2. <u>Appeals filed In-Person:</u> The appeal application can be obtained in the Lobby of the City Administration Building located at 202 'C' Street, San Diego, CA 92101. The completed appeal package must include the required appeal fee in the form of a check payable to the City Treasurer to: **City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101.**
