# **NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION**

**PROJECT NAME/NUMBER:** Special Event Permit - San Diego CIF Cross Country Championships

**COMMUNITY PLAN AREA:** Balboa Park

**COUNCIL DISTRICT:** 3

**LOCATION:** Morley Field in Balboa Park

**PROJECT DESCRIPTION:** Special Event Permit for a high school cross country race event that would occur on Morley Field trails on November 12, 2022. There would be use of temporary structures, tents, sound amplifications, generators, and fencing and/or barriers as part of the event. Noise associated with the event activities and set-up/dismantling would occur from 9 AM on November 11, 2022 to 4:30 PM on November 12, 2022. Set-up would occur on November 11, 2022 from 9 AM to 1:30 PM, the event will occur on November 12, 2022 from 6:16 AM to 2:40 PM and dismantling would follow from 2:40 PM to 4:30 PM. The race routes would occur on trails within Morley Field (see attached map).

A road closure associated with the event would occur on November 12, 2022 from 6:30 AM until 2:45 PM and would include Jacaranda Place between Arnold Drive and Pershing Drive (both directions) and on Joe Schloss Way from Jacaranda Place to the parking lot in the southbound direction. Approximate number of attendees is 3000.

**ENTITY CONSIDERING PROJECT APPROVAL:** City of San Diego

**ENVIRONMENTAL DETERMINATION:** Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

**ENTITY MAKING ENVIRONMENTAL DETERMINATION:** City of San Diego Mayor-Appointed Designee

**STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION:** The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing,

licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

Applications to appeal CEQA determination to the City Council must be filed with the Office of the Clerk within 5 business days from the date of the posting of this Notice (**November 1, 2022**). During the Statewide "Safer-at-Home" directive to reduce the spread of COVID-19, beginning March 19, 2021, appeals to the City Clerk must be filed by email or US Mail as follows:

The appeal filing fee must be postmarked within 5 business days of the date the appeal is filed.
2. Appeals filed In-Person: The appeal application can be obtained in the Lobby of the City Administration Building located at 202 'C' Street, San Diego, CA 92101. The completed appeal package must include the required appeal fee in the form of a check payable to the City Treasurer to: **City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101**.
