NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

SPECIAL EVENTS DEPARTMENT

PROJECT NAME/NUMBER: Special Event Permit – Ryan Bowers Suicide Prevention Run/Walk

COMMUNITY PLAN AREAS: Ocean Beach

COUNCIL DISTRICT: 2

LOCATION: Abbot Street, Newport Ave and Sunset Cliffs Blvd and the beach area adjacent to the OB Pier

PROJECT DESCRIPTION: Special Event Permit for the Ryan Bowers Suicide Prevention Run/Walk that would occur on December 11, 2022 along Newport Ave and Sunset Cliffs Blvd and the beach area adjacent to the OB Pier. The event would include four stages, canopies, fencing and/or barriers, onsite food preparation, food trucks, performance & entertainment, sound amplification and portable restrooms. Noise associated with the event activities and set-up/ dismantling would occur from 5:30 AM to 3 PM. Set up would occur from 5:30 AM to 7 AM, the event would occur from 7 AM to 2 PM and dismantling would occur from 2 PM to 3 PM.

Road closures associated with the event would take place from 7 AM to 3 PM on December 11, 2022 and would include <u>Abbot Street</u> (eastbound) from Newton Street to Sunset Cliffs Blvd, <u>Sunset Cliffs</u> <u>Blvd</u> (southbound) from Newport Ave to Landera St, and <u>Newport Ave</u> from Abbot St to Sunset Blvd.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego

conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

The appeal filing fee must be postmarked within 5 business days of the date the appeal is filed.
- 2. <u>Appeals filed In-Person:</u> The appeal application can be obtained in the Lobby of the City Administration Building located at 202 'C' Street, San Diego, CA 92101. The completed appeal package must include the required appeal fee in the form of a check payable to the City Treasurer to: City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101.
