NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

and K Street (see attached map)

PROJECT DESCRIPTION: Special Event Permit for the Gaslamp Holiday Pet Parade that would occur on December 17, 2022 on 5th Avenue between L Street and E Street and 4th Avenue between E Street and K Street (see attached map). The event would include the parade route, floats, marching bands, pets walking, performances, sound amplification, and a pet contest. Noise associated with the event activities and set-up/dismantling would occur from 8 AM until 6 PM on December 17, 2022. Set-up would occur from 8 AM until 1 PM, the event would occur from 1 PM until 2:30 PM, and dismantling would occur from 2:30 PM until 6 PM.

The following road closures would occur on December 17, 2022 during the following times: 5th Ave from K St to E St from 1 PM to 2:30 PM,

4th Ave between E St and K St from 1 PM to 2:30 PM, E Street from 4th Ave to 5 Ave from 1 PM to 2:30 PM, 5th Ave from K St to L St from 11 AM to 2:30 PM, K St from 4th Ave to 5th Ave from 11 AM to 2:30 PM,

Parking would be removed at the following locations: 5th Ave from K St to E St from 12 PM to 2:30 PM, 4th Ave from E St to K St from 12 PM to 2:30 PM, E St from 4th Ave to 5th Ave from 12 PM to 2:30 PM, K St from 4th Ave to 6th Ave from 11 AM to 2:30 PM, 5th Ave from K St to L St from 11 AM to 2:30 PM.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

Applications to appeal CEQA determination to the City Council must be filed with the Office of the Clerk within 5 business days from the date of the posting of this Notice (**December 13, 2022**). During the Statewide "Safer-at-Home" directive to reduce the spread of COVID-19, beginning March 19, 2021, appeals to the City Clerk must be filed by email or US Mail as follows:

- 1. Appeals filed via E-mail: Send the appeal by email to Hearings1@sandiego.gov; your email appeal will be acknowledged within 24 hours. The appeal application can be obtained here. You must separately mail the appeal fee by check payable to the City Treasurer to: City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101. The appeal filing fee must be postmarked within 5 business days of the date the appeal is filed.
- 2. <u>Appeals filed In-Person:</u> The appeal application can be obtained in the Lobby of the City Administration Building located at 202 'C' Street, San Diego, CA 92101. The completed appeal package must include the required appeal fee in the form of a check payable to the City Treasurer to: City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101.

Parade Route

- The Pet Parade will begin on Fifth Avenue underneath the Gaslamp Arch. The parade will proceed northbound on Fifth Avenue.
- To avoid the artisan market, the route will proceed by turning left on J street, and right on to Fourth Ave for one block. The parade will turn right on to Island Ave to resume going northbound on Fifth.
- Then the route will turn right onto E Street and turn left onto Fourth Avenue
- The parade will head southbound on Fourth Avenue terminating at K Street
- · Fifth Avenue will be no parked
