PROJECT NAME/NUMBER: Special Event Permit – Little Italy Mercato Wednesday COMMUNITY PLAN AREA: Downtown COUNCIL DISTRICT: 3 LOCATION: Date Street between State Street and Kettner Blvd (see attached map)

PROJECT DESCRIPTION: Special Event Permit for a weekly farmers' market that would include the temporary use of produce vendors, merchandise vendors, food booths, entertainment, portable restrooms, canopies, generators, tables, and chairs that would occur on West Date Street between State Street and Kettner Boulevard every Wednesday in 2022 from January 4, 2023 to December 27, 2023. Noise associated with the event activities and set-up/dismantling would occur from 7 AM until 3:30 PM on each Wednesday. Every Wednesday in 2023, set-up would occur from 7 AM until 9:30 AM, the market would be open from 9:30 AM until 1:30 PM, and clean-up/dismantling would occur from 1:30 PM until 3:30 PM.

A road closure would be associated with the event and would include West Date Street between State Street and Kettner Boulevard from 7 AM until 3 PM.

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no

significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

During the Statewide "Safer-at-Home" directive to reduce the spread of COVID-19, beginning March 19, 2021, appeals to the City Clerk must be filed by email or US Mail as follows:

- <u>Appeals filed via E-mail</u>: Send the appeal by email to <u>Hearings1@sandiego.gov</u>; your email appeal will be acknowledged within 24 hours. The <u>appeal application can be obtained here</u>. You must separately mail the appeal fee by check payable to the City Treasurer to: City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101. The appeal filing fee must be postmarked within 5 business days of the date the appeal is filed.
- 2. <u>Appeals filed In-Person:</u> The appeal application can be obtained in the Lobby of the City Administration Building located at 202 'C' Street, San Diego, CA 92101. The completed appeal package must include the required appeal fee in the form of a check payable to the City Treasurer to: **City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101.**
