NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

SPECIAL EVENTS DEPARTMENT

PROJECT NAME/NUMBER: Special Event Permit – San Diego Tet Festival

COMMUNITY PLAN AREA: Mira Mesa

COUNCIL DISTRICT: 6

LOCATION: Mira Mesa Community Park, 8575 New Salem Street, San Diego, CA, 92126

PROJECT DESCRIPTION: Special Event Permit for the San Diego Tet Festival that would occur within the Mira Mesa Community Park (see attached map) on January 27, 28 & 29, 2023. The event would include activities, games, onsite food preparation, merchandise vendors, and live entertainment, generators, a petting zoo, barriers, lion dancing, firecrackers, animals, a pageant, and dancing, a fenced-in beer garden, two stages, canopies, tables, and chairs. Noise associated with the event activities and set-up/dismantling would occur from January 25, 2023 at 8 AM to January 30, 2023 at 12 PM. Set up would occur over five days: January 25, 2023 from 8 AM to 5 PM, January 26, 2023 from 8 AM to 9 PM, January 27, 2023 from 8 AM to 3 PM, January 28, 2023 from 8 AM to 11 AM and January 29, 2023 from 8 AM to 11 AM. The event would occur over three days: January 27, 2023 from 4 PM to 10 PM, January 28, 2023 from 11 AM to 10 PM, and January 29, 2023 from 11 AM to 9 PM. Dismantling would occur on January 29, 2023 from 9 PM to 10 PM and on January 30, 2023 from 8 AM to 12 PM.

There would be no road closures associated with this event, however, additional traffic and potential delays may occur.

ENTITY CONSIDERING PROJECT APPROVAL: City of San Diego

ENVIRONMENTAL DETERMINATION: Categorically exempt from CEQA pursuant to State CEQA Guidelines Section 15301 (Existing Facilities); Section 15304 (Minor Alterations to Land); Section 15311 (Accessory Structures).

ENTITY MAKING ENVIRONMENTAL DETERMINATION: City of San Diego Mayor-Appointed Designee

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for

causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

Applications to appeal CEQA determination to the City Council must be filed with the Office of the Clerk within 5 business days from the date of the posting of this Notice (**December 12, 2022**). During the Statewide "Safer-at-Home" directive to reduce the spread of COVID-19, beginning March 19, 2021, appeals to the City Clerk must be filed by email or US Mail as follows:

The appeal filing fee must be postmarked within 5 business days of the date the appeal is filed.
2. Appeals filed In-Person: The appeal application can be obtained in the Lobby of the City Administration Building located at 202 'C' Street, San Diego, CA 92101. The completed appeal package must include the required appeal fee in the form of a check payable to the City Treasurer to: **City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101**.
