NOTICE OF RIGHT TO APPEAL ENVIRONMENTAL DETERMINATION

SPECIAL EVENTS DEPARTMENT

PROJECT NAME: Special Event Permit – Hot Chocolate Run

COMMUNITY PLAN AREA: Downtown, Balboa Park and Greater Golden Hill, North Park

COUNCIL DISTRICT: 3

LOCATION: Roadways within East Village, Balboa Park, North Park and Greater Golden Hill

PROJECT DESCRIPTION: Special Event Permit for that portion of a 15K/10K/5K run event and post-race party that would occur within the City's right-of-way jurisdiction on March 19, 2023. The event would include stages, sound amplification, performances & entertainment, tents, structures such as platforms and/or scaffolding, generators, portable restrooms, trash and recycling containers, fencing, onsite food preparation, food, and beverages. Sound amplification would occur from 5:45 AM to 11 AM on March 19, 2023. Noise associated with the event activities and set-up/dismantling would occur from 12 PM on March 16, 2023 to 4 PM on March 19, 2023. Set up time would occur from 12 PM to 5 PM on March 16, 2023, from 8 AM to 5 PM on March 17, 2023 and the March 18, 2023. On March 19, 2023, the event would occur from 6 AM to 11 AM and dismantling would occur from 11 AM to 4 PM.

The run routes would occur on city streets, and the post-race party would occur on private property. See route maps and the road closures and times of closures attached. Traffic delays would be expected.

STATEMENT SUPPORTING REASON FOR ENVIRONMENTAL DETERMINATION: The City of San Diego conducted an environmental review that determined the project would not have the potential for causing a significant effect on the environment pursuant to State CEQA Guidelines Section(s): Section 15301 (Existing Facilities) which allows for the operation, repair, maintenance, permitting, leasing, licensing or minor alterations of existing public or private structures or facilities involving negligible or no expansion of use; Section 15304 (Minor Alterations to Land) which allows for minor, temporary use of land that has negligible or no permanent effects on the environment; Section 15311 (Accessory

Structures) which allows for construction, or placement of minor structures accessory to existing commercial, industrial, or institutional facilities, including, but not limited to, temporary use items in publicly owned facilities or other facilities designated for public use; and where the exceptions listed in CEQA Guidelines Section 15300.2 would not apply in that no cumulative impacts were identified; no significant effects on the environment were identified; the project is not adjacent to a scenic highway; no historical resources would be affected by the action; and the project was not identified on a list of hazardous waste sites pursuant to Section 65962.5 of the Government Code.

The appeal filing fee must be postmarked within 5 business days of the date the appeal is filed.
- 2. <u>Appeals filed In-Person:</u> The appeal application can be obtained in the Lobby of the City Administration Building located at 202 'C' Street, San Diego, CA 92101. The completed appeal package must include the required appeal fee in the form of a check payable to the City Treasurer to: City Clerk/Appeal, MS 2A, 202 C Street, San Diego, CA 92101.


